

**Subject:** Contract Award Recommendation in the Amount of \$416,609.42 to R & D Electric, Inc. for the People's Transportation Plan Project Entitled Solar Powered Electronic Speed Feedback Signs – South I, Countywide; and Authorizing the Use of Charter County Transportation Surtax Funds

**Recommendation**

The attached Contract Award Recommendation for the People's Transportation Plan (PTP) project entitled *Solar Powered Electronic Speed Feedback Signs – South I, Countywide* (Project MCC 7040 Plan - CICC 7040-0/07 Request for Price Quotation No. 20130206) in the amount of \$416,609.42 to R & D Electric, Inc., was prepared by the Public Works and Waste Management Department (PWWM) and is recommended for approval by the Board of County Commissioners (BCC).

This Contract Award Recommendation is placed for Committee review pursuant to Miami-Dade County Code Section 29-124(f). This Contract Award Recommendation may only be considered by the BCC if the Citizens' Independent Transportation Trust (CITT) has forwarded a recommendation to the BCC prior to the date scheduled for BCC consideration or forty-five (45) days have elapsed since the filing with the Clerk of the Board of this contract award recommendation. If the CITT has not forwarded a recommendation and forty-five (45) days have not elapsed since the filing of this award recommendation, I will request a withdrawal of this item.

**Scope**

The work to be performed under this Contract includes installation of solar powered electronic speed feedback signs at various elementary and middle schools within Miami-Dade County (see attached list).

**Fiscal Impact/Funding Source**

The fiscal impact will be approximately \$416,609.42 and will be funded from the Charter County Transportation Sales Surtax Bond Sale Proceeds. The base contract amount is \$368,095.00, with the total amount being inclusive of contingency and dedicated allowance amounts. There is no fiscal impact to operations or maintenance.

The proposed improvements qualify under the allowable work categories included in the PTP Neighborhood Improvements Section. Specific funding for this project will be allocated from the PTP Bond Program and may be supplemented by other funding sources when available. The funding index code for this project is CPEPTP700SCH (FY 2013-14 Adopted Capital Project 608740).

**Delegation of Authority**

No additional authority is being requested within the body of this Contract.

**Track Record/Monitor**

R & D Electric, Inc. is currently performing work for PWWM at a satisfactory level. The Capital Improvements Information System (CIIS) database lists 31 awarded construction contracts as follows:

- one (1) from Aviation,
- nine (9) from Public Housing and Community Development,
- five (5) from Internal Services
- one (1) from Parks, Recreation and Open Spaces,
- one (1) from Police,
- three (3) from Seaport,
- two (2) from Transit,
- two (2) from Water and Sewer, and
- seven (7) from the Public Works and Waste Management Department.

The referenced database also lists a total of nine (9) contractor performance evaluations with an overall performance rating of 3.2 (satisfactory performance), out of a possible 4.0 (superior performance) rating. The Regulatory and Economic Resources Department, Small Business Development Division (SBD) History of Violation's report lists no violations for this contractor.

According to the Florida Department of State, Division of Corporations, R & D Electric, Inc., Company Principals are Rafael Echarri and Daniel Echarri and the Company's address is listed as 7330 NW 12 Street, Miami, Florida 33166.

Following PWWM's standard operating procedures, after award of this Contract a pre-construction meeting will be scheduled. The person responsible for all PTP projects in PWWM is Capital Improvements Manager, Mr. Alejandro Martinez-Esteve, RA, LEED AP. Following completion of the award process, the project will be assigned to Mr. Oscar Rubio, Project Coordinator, for day-to-day responsibilities.

**Background**

As part of the PTP Neighborhood Improvements initiative, PWWM continues to take advantage of various contracting mechanisms such as the Miscellaneous Construction Contracting process available under the MCC 7040 Program. Through this process, PWWM forwards a Request for Price Quotation, by way of facsimile transmission, to a pool of pre-qualified Community Small Business Enterprise (CSBE) contractors for the respective trade. Additionally, all solicitations are available on-line through the Miami-Dade County portal under the "Procurement Solicitations" link. The project's award evaluation is based upon the bid submitted by the lowest responsive, responsible bidder for the project.


PWWM staff determined that the scope of work for this project qualified for a 100 percent CSBE participation. A Community Workforce Program Goal was deemed not applicable to this RPQ. On July 3, 2014, PWWM forwarded RPQ No. 20130206, utilizing the MCC 7040 Plan - CICC 7040-0/07 Contract, to a list of 52 pre-qualified firms. A total of two (2) firms purchased contract documents and the two (2) firms proffered a bid.

On August 6, 2014, R & D Electric, Inc. proffered the lowest base bid of \$368,095.00; 19 percent above the County's cost estimate. The second lowest bidder, Statewide Electrical Services, Inc., proffered a base bid of \$379,160.00, 22 percent above the County's cost estimate.

The Engineer's estimate for this project was based on the most recent project with a similar scope for work which bids were opened in November 20, 2013 (Project No. 20130233). The prices received for this project are very similar to contract prices received in 2011 on similar projects. PWWM does not foresee that re-advertising this project would result in lower prices, and would cause a delay in the implementation of the proposed work.

Based on the results of the solicitation, PWWM issued a recommendation for award on August 18, 2014 for RPQ No. 20130206 to R & D Electric, Inc., with the stipulation that approval for this project must be obtained from the CITT and the BCC.

The work to be accomplished for this project consists of, but is not limited to, furnishing all supervision, labor, required materials, equipment, and tools to perform all operations necessary for the installation of solar powered electronic speed feedback signs. The work includes sign installation, removal and disposal of existing concrete sidewalk, construction of new concrete sidewalk, tree trimming, and sign relocation as directed by the Engineer.

This letter will serve as your notification that you have been recommended for award for the above referenced RPQ based on your Price Quotation submitted on Wednesday, August 6, 2014. The total RPQ amount is for four hundred sixteen thousand six hundred nine dollars and forty-two cents (\$416,609.42). This includes a base contract amount of three hundred sixty-eight thousand ninety-five dollars and zero cents (\$368,095.00), a contingency amount of thirty-six thousand eight hundred nine dollars and fifty cents (\$36,809.50), and dedicated allowances totaling eleven thousand seven hundred four dollars and ninety-two cents (\$11,704.92). The contract duration is established as **270-calendar days**. However, the recommendation of award is contingent upon the submission of the required items listed below:

1. Performance and Payment Bond as required in Contract No. MCC 7040 Plan, Section 2.0 Special Conditions, Page 16, Article 2.11, **PERFORMANCE AND PAYMENT BOND**. (The **original attached documents** must be used and three (3) sets must be provided).
2. Letter from Bonding Agent granting Miami-Dade County authorization to date the Performance Bond.
3. Copies of current insurance certificates.
4. Copies of required license(s).

The preceding documents are required as outlined within the Contract MCC 7040 Plan and to be submitted within 10 business days. Failure to submit the document(s) within the specified time, or any extension granted, will result in the award being rescinded.

Subsequent to the review and approval of the aforementioned documents, you are required to obtain the required permits in the time stipulated in the RPQ. Upon obtaining the permit(s), a copy(s) must be submitted to the Project Manager prior to commencement of work. No work is to be performed without a permit unless the Project Manager issues a written directive to proceed without permit(s).



Further, it shall be understood that since proceeds from the Charter County Transportation System Sales Surtax levied pursuant to Section 29.121 of the Code of Miami-Dade County may be used to pay for all or some part of the cost of this contract, no award of this contract shall be effective and thereby give rise to a contractual relationship with the County unless and until the Citizens' Independent Transportation Trust (CITT) and the County Commission have approved the award of the contract, and such award becomes final (either by expiration of 10 days after such award without veto by the Mayor, or by Commission override of a veto).


