RESOLUTION SETTING POLICY FOR MIAMI-DADE COUNTY; ENCOURAGING THAT THE DEVELOPMENT TEAM OF ANY ENTITY APPLYING FOR DOCUMENTARY SURTAX FUNDS BE DIVERSIFIED AND ASPIRE TO BE CONSISTENT WITH AND REFLECT THE DIVERSITY OF THE MIAMI-DADE COUNTY COMMUNITY

WHEREAS, this Board wishes to assure that all segments of the County have a full, fair and meaningful opportunity to participate in County-funded contracting regardless of race, gender or ethnic origin; and

WHEREAS, according to the 2013 American Community Survey released by the United States Census Bureau, 65.6% of Miami-Dade County's population is Hispanic or Latino, 15.0% is Non-Hispanic White, 16.8% is Non-Hispanic Black or African American, 1.6% Non-Hispanic Asian, and 1.0% Other, reflecting a uniquely diverse community; and

WHEREAS, the development teams of entities applying for documentary surtax funds from the County consist of many professionals, including contractors, engineers, architects, lawyers and developers; and

WHEREAS, because of the many and varied type of professionals involved in the development teams of entities applying for documentary surtax funds, there exists a unique opportunity for the hiring and selection of a diverse group of professionals that is reflective of the diversity of the Miami-Dade County community,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board sets a policy for Miami-Dade County encouraging the development teams of entities applying for
