RESOLUTION DIRECTING THE MAYOR OR DESIGNEE TO PREPARE A REPORT AND PLAN FOR THE DEVELOPMENT, USE, AND MAINTENANCE OF COUNTY-OWNED PROPERTY IN THE DOWNTOWN MIAMI AREA

WHEREAS, the Downtown Miami area, as generally bounded by I-395 to the North, Biscayne Bay to the East, the Miami River to the South, and I-95 to the West (hereinafter, "Downtown") is a cultural, financial, and commercial center in South Florida, tracing its present-day history back to the 19th century; and

WHEREAS, in recent years, Downtown has become one of the fastest-growing areas in South Florida, with large scale high-rise construction and significant population increase; and

WHEREAS, Downtown is home to major museums, parks, education centers, banks, businesses, company headquarters, courthouses, government offices, theaters, shops, and many of the oldest and most historic buildings in Miami; and

WHEREAS, Downtown is located within the City of Miami; and

WHEREAS, Downtown is also home to property owned by Miami-Dade County; and

WHEREAS, there is a strong public interest in seeing that such County-owned property is developed, used, and maintained in an efficient and well-planned manner to best serve the needs of the County and its people; and

WHEREAS, to further this strong public interest, the Mayor or designee should assess the manner in which County-owned property in Downtown is currently being developed, used, and maintained, as well as how best to develop, use, and maintain such property going forward, so that the needs and demands of the County and its people are properly served,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. This Board directs the Mayor or designee to, after consultation with the City of Miami >>and the Miami Downtown Development Authority <<¹, prepare a report and plan for the development, use, and maintenance of County-owned property in the Downtown Miami area. The report and plan should include an assessment of the manner in which County-owned property in Downtown is currently being developed, used, and maintained, as well as an assessment of how best to develop, use, and maintain such property going forward, so that the needs and demands of the County and its people are properly served. The report and plan should also address the costs associated with implementation.

Section 2. The Mayor or designee shall provide the report and plan to this Board within 60 days of the effective date of this resolution and shall place the completed report and plan on an agenda of the Board pursuant to Ordinance No. 14-65.

Section 3. The Clerk of the Board shall also transmit a copy of the report and plan to the City of Miami.
