RESOLUTION SETTING POLICY FOR **MIAMI-DADE** COUNTY RELATED TO PURCHASES OF AMERICAN FLAGS; PROVIDING THAT FUTURE AMERICAN FLAG PURCHASES BY MIAMI-DADE COUNTY ONLY BE MADE FROM PERCENT AMERICAN-MANUFACTURED 100 MATERIALS; FURTHER URGING CONGRESS TO PASS LEGISLATION REQUIRING THE FEDERAL GOVERNMENT TO PURCHASE ONLY AMERICAN FLAGS MADE FROM 100 PERCENT AMERICAN-MANUFACTURED MATERIALS

WHEREAS, in 2014, the United States Census Bureau estimated the value of United States imports of American flags in 2012 was \$4.0 million and the value of U.S. exports of American flags was \$781,222; and

WHEREAS, United States flag purchases are currently subject to the Buy American Act, 41 U.S.C. sections 8301-8305, which requires only that 50 percent of the cost of flag materials be manufactured in the United States; and

WHEREAS, during the 113th Congress, Senator Sherrod Brown (D – Ohio) filed S. 1214, and Representative Bruce Braley (D – Iowa) filed H.R. 2355, both entitled the All-American Flag Act; and

WHEREAS, the All-American Flag Act provided that the United States government may only purchase flags that are 100 percent manufactured in the United States, from articles, materials, or supplies 100 percent of which are grown, produced, or manufactured in the United States; and

WHEREAS, Miami-Dade County spends thousands of dollars per year on American flags, many of which must be replaced multiple times throughout the year due to wear and tear and on average cost approximately \$50 per flag; and

WHEREAS, this Board wishes to express its support of our nation's symbol, and the values undergirding it, and to encourage the production of that symbol from goods grown, produced or manufactured within the United States,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Sets as policy for Miami-Dade County that all American flags purchased by the County be 100 percent manufactured in the United States, from articles, materials, or supplies 100 percent of which are grown, produced or manufactured in the United States.

Section 2. Urges Congress to enact legislation requiring the federal government to only purchase American flags made from 100 percent American-manufactured materials.

Section 3. Directs the Clerk of the Board to transmit a certified copy of this resolution to the members of the Florida Congressional Delegation, Senator Sherrod Brown and Representative Bruce Braley.

<u>Section 4</u>. Directs the County's federal lobbyists to advocate for the passage of the legislation set forth in Section 2 above, and authorizes and directs the Office of Intergovernmental Affairs to include this item in the 2015 Federal Legislative Package when it is presented to the Board.
