Recommendation

The following waiver of plat is hereby submitted for consideration by the Board of County Commissioners for approval. This plat is bounded on the north approximately 482 feet south of SW 12 Street, on the east by SW 89 Court, on the south approximately 602 feet north of SW 16 Street, and on the west approximately 180 feet east of SW 90 Avenue. The Miami-Dade County Plat Committee, comprised of representatives from the Florida Department of Transportation, the Florida Department of Health, the Miami-Dade County School Board and Miami-Dade County Departments of Fire Rescue, Parks, Recreation and Open Spaces, Regulatory and Economic Resources (RER), Public Works and Waste Management (PWWM), and Water and Sewer, recommends approval of this waiver of plat.

Scope

This waiver of plat is located within the boundaries of Commission District 10, Commissioner Senator Javier D. Souto.

Fiscal Impact/Funding Source

The fiscal impact to the County will be approximately \$100.00 per year for the annual maintenance cost of the recently constructed portion of road adjacent to this project, which will be funded through PWWM General Fund allocation.
