# RESOLUTION NO.

RESOLUTION APPROVING 2015 FEDERAL LEGISLATIVE PRIORITIES

WHEREAS, the first session of the 114th United States Congress is scheduled to convene on January 3, 2015; and

WHEREAS, on January 24, 2012, this Board approved Resolution No. R-59-12, which directed the Office of Intergovernmental Affairs, when it presents the proposed federal or state legislative agenda respectively to the Board, to include all "urging" resolutions and other resolutions related to federal or state legislation passed by the Board of County Commissioners to date for the current Congress or session; and

WHEREAS, on September 17, 2013, this Board approved Resolution No. R-764-13, which directed that the federal and state legislative packages each be presented to the Board in two separate companion items, one consisting of no more than ten priorities for distribution to the Miami-Dade Legislative Delegation and the other to include guiding principles, Board "urging" resolutions enacted to date and departmental items for approval by the Board; and

WHEREAS, Resolution No. R-764-13 provided that, upon the priorities being approved and effective, incorporating any amendments by the Board, the Chair of the Board, or a County Commissioner designated by the Chair, shall transmit the priorities to the respective federal or state legislative delegation; and

WHEREAS, the proposed 2015 federal legislative priorities are attached to this resolution and incorporated by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the federal legislative priorities for the 2015 session as set forth in the attached.

Section 2. Directs the County's federal lobbyists to advocate for the federal legislative priorities for the 2015 session.

The Bella Bill Pediatric Cancer R-564-14: Resolution URGING Congress to enact the "Bella Bill" to advance pediatric cancer research
Medicare Fraud Enforcement & Prevention R-545-14: Resolution URGING Congress to pass the Medicare Fraud Enforcement and Prevention Act of 2013, H.R. 418, or similar legislation that would reduce Medicare waste, fraud, and abuse
Central Everglades Planning Project R-470-14: Resolution URGING Congress to authorize and provide funding for the Central Everglades Planning Project
NOTE: The Water Resources Reform and Development Act of 2014, which became law on 06/10/2014, included a provision that allows the Central Everglades Planning Project (CEPP) to proceed without federal authorization, using non-federal money once they receive the Army Corps Chief's report and can seek federal re-imbursement at a later date. Public Review and the comment period concluded in October.

R-772-13: Resolution URGING Congress, the Florida legislature, the Florida Secretary of State and other applicable federal and state agencies to provide funding for the restoration of Naval Air Station Richmond Building No. 25 as the Miami Military Museum

novem Paragraph	<b>U.S. CBP and CBP-Ag Staffing at MIA</b> - <b>ADVOCATE</b> for adequate CBP and CBP-Ag staffing at MIA.
