Subject: Contract Award Recommendation in the Amount of \$1,475,725.10 to Acre Engineering and Construction, Inc. for the People's Transportation Plan Project entitled Improvements to Old Cutler Trail Bicycle Route – Phase II, located within Commission District 7; and Authorizing the Use of Charter County Transportation Surtax Funds for Such Purposes

Recommendation

The attached Contract Award Recommendation for the People's Transportation Plan (PTP) project entitled *Improvements to Old Cutler Trail Bicycle Route - Phase II, FM No. 251265-6, located within Commission District 7 (Project MCC 7360 Plan - CICC 7360-0/08 Request for Price Quotation (RPQ) No. 20130278)* in the amount of \$1,475,725.10 to Acre Engineering and Construction, Inc., was prepared by the Public Works and Waste Management Department (PWWM) and is recommended for approval by the Board of County Commissioners (BCC).

This Contract Award Recommendation is placed for Committee review pursuant to Miami-Dade County Code Section 29-124(f). This Contract Award Recommendation may only be considered by the BCC if the Citizens' Independent Transportation Trust (CITT) has forwarded a recommendation to the BCC prior to the date scheduled for BCC consideration or forty-five (45) days have elapsed since the filing with the Clerk of the Board of this contract award recommendation. If the CITT has not forwarded a recommendation and forty-five (45) days have not elapsed since the filing of this award recommendation, I will request a withdrawal of this item.

Scope

The work to be performed under this Contract includes improvements to Old Cutler Trail bicycle route, from SW 136 Street/SW 63 Avenue to Cartagena Plaza, located within Commissioner Xavier L. Suarez's District 7.

Fiscal Impact/Funding Source

The fiscal impact will be approximately \$1,475,725.10 and will be funded from the Charter County Transportation Sales Surtax Bond Sale Proceeds. The base contract amount is \$1,269,341.00, with the total amount being inclusive of contingency and dedicated allowance amounts. The funding index code for this project is CPEPTP707BWY (FY 2013-14 Adopted Capital Project 6037700). Any other applicable funding source may subsidize the Charter County Transportation Surtax Funds allocated to this Contract.

A Local Agency Program (LAP) Agreement between Miami-Dade County and the Florida Department of Transportation (FDOT) was approved under BCC Resolution No. R-791-12. The LAP Agreement provides the County, with up to \$1,319,213.00 in Transportation Enhancement Program funds to reimburse the County, for the project's design, construction, and construction engineering inspection.

The additional annual estimated maintenance costs for the improvements will be approximately \$4,610.00 respectively, and will be funded through PWWM's General Fund allocation. There are no operational costs associated with this contract. The life expectancy for the bicycle path is approximately 20 years.

Delegation of Authority

No additional authority is being requested within the body of this Contract.

Track Record/Monitor

The Capital Improvements Information System (CIIS) database lists 43 awarded construction contracts from each of the following departments:

- one (1) from Internal Services,
- one (1) from Fire,
- two (2) from Transit,
- 14 from Parks, Recreation and Open Spaces,
- four (4) from Seaport,
- 13 from Water and Sewer, and
- eight (8) from PWWM.

The referenced database also lists a total of 41 contractor performance evaluations with an overall performance rating of 3.9 (satisfactory performance), out of a possible 4.0 (superior performance) rating. The Internal Services Department, Small Business Development Division (SBD) History of Violation's report lists no violations for this contractor.

According to the Florida Department of State, Division of Corporations, Acre Engineering and Construction, Inc., Company Principals are Jose Angel Bustos and Doris Baez and the Company's address is listed as 2451 NW 109 Avenue, Unit 4, Miami, Florida 33172.

Following PWWM's standard operating procedures, after award of this Contract, a pre-construction meeting will be scheduled. The person responsible for all PTP projects in PWWM is Mr. Alejandro Martinez-Estevé, RA, LEED AP, Manager, Capital Improvements Section. Following completion of the award process, the project will be assigned to Mr. Leo Salgueiro, Project Coordinator, for day-to-day responsibilities.

Background

As part of the PTP Neighborhood Improvements initiative, PWWM continues to take advantage of various contracting mechanisms such as the Miscellaneous Construction Contracting process available under the MCC 7360 Program. Through this process, PWWM forwards an RPQ by way of facsimile transmission to a pool of firms that have registered with the Internal Services Department for the respective trade. Additionally, PWWM advertises the project in the *Daily Business Review* and all solicitations are available on-line through the Miami-Dade County portal under the "Procurement Solicitations" <http://www.miamidade.gov/procurement/solicitations.asp>. The project's award evaluation is based upon the bid submitted by the lowest responsive and responsible bidder for the project.

PWWM submitted to SBD its contract measure recommendation for Disadvantage Business Enterprise (DBE) participation for this RPQ. SBD completed its Project Review and Analysis, and established an 8.60 percent DBE participation goal. A Community Workforce Program Goal was deemed not applicable to this RPQ.

On June 26, 2014, PWWM forwarded RPQ No. 20130278, utilizing the MCC 7360 Plan - CICC 7360-0/08 Contract, to a list of 70 pre-qualified firms. A total of one (1) firm purchased contract documents and four (4) firms proffered a bid.

On July 30, 2014, Acre Engineering and Construction, Inc. proffered the lowest responsive and responsible base bid of \$1,269,341.00, three (3) percent below the County's cost estimate. The second lowest bidder, Acosta Tractors, Inc. proffered a base bid of \$1,586,337.75, 21 percent above the County's cost estimate. The third lowest bidder, Williams Paving Company, Inc. proffered a base bid of \$1,606,668.75, 23 percent above the County's cost estimate. The fourth lowest bidder, ENCO, LLC., proffered a base bid of \$1,811,316.25, 38 percent above the County's cost estimate. Based on the results of the solicitation, and FDOT's concurrence and approval to proceed with the project's award on October 27, 2014, PWWM issued a Recommendation for Award on October 28, 2014 for RPQ No. 20130278 to Acre Engineering and Construction, Inc., with the stipulation that approval for this project must be obtained from the CITT and BCC.

The work to be accomplished for this project consists of, but is not limited to, furnishing all supervision, labor, required materials, equipment, and tools to perform all operations necessary for the improvements to the Old Cutler Road Bicycle Route. The project consists of the following changes to the route: reconstruction; widening the bicycle route a minimum of 8' wide and relocation further away from the traffic lanes where possible; curb and gutters; installing remedial drainage as necessary; resurfacing segments that are to remain; pruning trees and tree roots; installing root barriers to prevent future damage; and installing regulatory signage for bicycles and pedestrians.


