RESOLUTION DISTRIBUTING FY 2013-14 OFFICE OF THE CHAIR IN-KIND FUNDS TO MEMBERS OF THE BOARD OF COUNTY COMMISSIONERS ON AN EQUAL BASIS

WHEREAS, the FY 2013-14 Miami-Dade County budget allocated in-kind funds to the Office of the Chair (hereinafter "FY 2013-14 Office of the Chair In-kind Fund"); and

WHEREAS, the FY 2013-14 Office of the Chair In-kind Fund currently contains \$26,780.00; and

WHEREAS, the Chairwoman of the Board of County Commissioners wishes to distribute the remaining funds in the FY 2013-14 Office of the Chair In-kind Fund on an equal basis to the thirteen members of the County Commission; and
