RESOLUTION DIRECTING THE MAYOR OR MAYOR'S DESIGNEE TO PREPARE A REQUEST FOR PROPOSALS TO PROVIDE FREE WIRELESS HIGH FIDELITY (WI-FI) INTERNET SERVICE AT MIAMI INTERNATIONAL AIRPORT

WHEREAS, on May 6, 2008, the Board of County Commissioners of Miami-Dade County (the "Board") adopted Resolution No. R-461-08 awarding a non-exclusive licensing agreement to Electronic Media Systems, Inc. ("EMS"), a local Miami firm, to provide Wireless High Fidelity ("Wi-Fi") internet service at the Miami International Airport ("MIA"); and

WHEREAS, on October 21, 2013, the Miami-Dade Aviation Department ("MDAD") granted its consent to the acquisition of EMS by Boingo Wireless Inc. ("Boingo") and the non-exclusive license agreement to provide Wi-Fi was assigned to Boingo (the "Existing License Agreement"); and

WHEREAS, the Existing License Agreement expires in June 2015; and

WHEREAS, MIA currently charges \$4.95 for the first 30 minutes of wireless internet access or \$7.95 for 24 continuous hours of wireless internet access; and

WHEREAS, according to a July 2013 survey conducted by the Global Gateway Alliance, 15 of the 20 largest airports in the country provide free Wi-Fi; and

WHEREAS, it is necessary that the County commence the preparations for the June 2015 expiration of the Existing License Agreement as early as possible in order to maximize sponsorship and advertising opportunities as well as to attract qualified proposers; and

WHEREAS, this Board desires to direct the Mayor or Mayor's designee to prepare a request for proposals ("RFP") for the selection of a vendor or vendors to provide free Wi-Fi at MIA following the expiration of the Existing License Agreement; and

WHEREAS, this Board further desires that the RFP may consider including provisions and allowances for advertising and sponsorship opportunities in order to generate revenue and reduce reliance on the annual MDAD operating budget,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. The Mayor or Mayor's designee is hereby directed to prepare and submit to this Board for approval a proposed Request for Proposals inviting interested vendors to submit proposals to provide free user end Wireless High Fidelity internet service at Miami International Airport.

Section 2. The Mayor or Mayor's designee is hereby directed to prepare the necessary Request for Proposals documents and to present them to this Board for approval within thirty days of the effective date of this Resolution. The Request for Proposals shall at a minimum include a free basic user end connection that operates at the fastest speed when compared to other airports that offer free wireless high fidelity internet service and contains an option to pay for upgraded premium services. The Request for Proposal may contain provisions and allowances for advertising and sponsorship opportunities in order to generate revenue and reduce reliance on the annual operating budget of Miami-Dade Aviation Department.

The Prime Sponsor of the foregoing resolution is Commissioner Juan C. Zapata.
