RESOLUTION WAIVING BY A TWO-THIRDS VOTE OF MEMBERS PRESENT TERM LIMIT RESTRICTION FOR CONSTRUCTION TRADES QUALIFYING BOARD MEMBER JULIE COFFEY; REAPPOINTING JULIE COFFEY TO THE CONSTRUCTION TRADES QUALIFYING BOARD FOR ANOTHER TERM

WHEREAS, on January 21, 2010, the Board of County Commissioners enacted Ordinance No. 10-06, amending section 2-11.38.2 of the Code of Miami-Dade County, Florida to permit the waiver of term limits for members of County boards; and

WHEREAS, Section 2-11.38.2 of the Code of Miami-Dade County, which governs the Construction Trades Qualifying Board with respect to term limits, states that, "No board member shall serve more than eight (8) consecutive years on any one (1) board"; and

WHEREAS, pursuant to Section 2-11.38.2 of the Code of Miami-Dade County, the Board of County Commissioners may, by resolution adopted by a two-thirds (2/3) vote of members present, waive a term limit applicable to a member of a County board; and

WHEREAS, pursuant to Section 10-20 of the Code of Miami-Dade County, term duration for members of the Construction Trades Qualifying Board is three (3) years; and

WHEREAS, Ms. Julie Coffey has been a valued member of the Construction Trades Qualifying Board, "A" Division, and has reached her term limit as a member of the Construction Trades Qualifying Board, "A" Division; and

WHEREAS, Ms. Julie Coffey's continued service as a member would aid in the effective operation of the Construction Trades Qualifying Board, "A" Division; and

WHEREAS, this Board wishes to waive the applicable term limit and reappoint Ms. Coffey to another three (3) year term as a member of the Construction Trades Qualifying Board, "A" Division,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

**Section 1.** The foregoing recitals are incorporated in this resolution and are approved.

Section 2. Pursuant to Section 2-11.38.2 of the Code of Miami-Dade County, this Board, by a two-thirds (2/3) vote of the members present, hereby waives the term limit restriction for Julie Coffey.

Section 3. This Board reappoints Julie Coffey to the Miami-Dade Construction Trades Qualifying Board, "A" Division, for an additional three (3) year term.

The Prime Sponsor of the foregoing resolution is Commissioner Sally A. Heyman. It was offered by Commissioner , who moved its adoption. The motion was seconded by Commissioner and upon being put to a vote, the vote was as follows:
