Recommendation

The following waiver of plat is hereby submitted for consideration by the Board of County Commissioners for approval. This plat is bounded on the north approximately 100 feet south of SW 98 Terrace, on the east approximately 540 feet west of SW 79 Avenue, on the south by SW 99 Street, and on the west approximately 660 feet east of SW 82 Avenue. The Miami-Dade County Plat Committee, comprised of representatives from the Florida Department of Transportation, the Florida Department of Health, the Miami-Dade County School Board and Miami-Dade County Departments of Fire Rescue, Parks, Recreation and Open Spaces, Regulatory and Economic Resources (RER), Public Works and Waste Management, and Water and Sewer, recommends approval of this waiver of plat.

Scope

This waiver of plat is located in Commission District 7, which is represented by Commissioner Xavier L. Suarez.

Fiscal Impact/Funding Source

There is no associated fiscal impact to Miami-Dade County with the approval of this waiver of plat; all improvements are in place.

RESOLUTION APPROVING THE WAIVER OF PLAT OF ERIK A. ESPINOSA AND JOSE R. ESPINOSA, JR., D-23547, LOCATED IN THE SOUTHEAST 1/4 OF SECTION 3, TOWNSHIP 55 SOUTH, RANGE 40 EAST (BOUNDED ON THE NORTH APPROXIMATELY 100 FEET SOUTH OF SW 98 TERRACE, ON THE EAST APPROXIMATELY 540 FEET WEST OF SW 79 AVENUE, ON THE SOUTH BY SW 99 STREET, AND ON THE WEST APPROXIMATELY 660 FEET EAST OF SW 82 AVENUE)

WHEREAS, Erik A. Espinosa and Jose R. Espinosa, Jr., have this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a portion of land lying and being in the Southeast 1/4 of Section 3, Township 55 South, Range 40 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,
