Resolution Authorizing Submittal of a Grant Application to Florida Inland Navigation

District, Waterways Assistance Program (FIND) for \$205,000.00 with Matching County Funds of \$225,000.00 for Renovations to the Wet-slips at Homestead Bayfront Marina

Recommendation

It is recommended that the Board of County Commissioners (Board) authorize the County Mayor or County Mayor's designee to apply to Florida Inland Navigation District's Waterways Assistance Program for \$205,000.00 with matching County funds of \$225,000.00 for renovations to the wet-slips at Homestead Bayfront Marina. It is further recommended that the Board authorize the County Mayor or County Mayor's designee to receive and expend funds and execute grant agreements, certain amendments and other documents as required by the grant upon review and final approval of the County Attorney's Office.

Scope

Homestead Bayfront Marina is located at 9698 S. W. 328 Street, Homestead, in Commission District 9, Commissioner Dennis Moss.

Fiscal Impact/Funding Source

The total cost of the project is \$430,000.00. If awarded, the FIND grant will provide funds of \$205,000.00 and the County will provide \$225,000.00 of project funding from PROS Index Code PRE130935014, Florida Boating Improvement Vessel Fee Allocation Fund. The project solely renovates existing facilities; therefore no additional operating cost will be incurred from completion of this project.

Track Record/Monitor

The Parks, Recreation and Open Spaces Department's (PROS) grants manager Gina Drakes will monitor and administer the proposed grant and ensure compliance with the resolution and terms of the grant.

Background

Florida Inland Navigation District is a Special Taxing District for the continued management and maintenance of the Atlantic Intracoastal Waterway. The application is due April 1, 2015 and is required to be accompanied by the adopted resolution. If awarded, the grant term will begin October 2015 and end September 2017. The project is scheduled to be completed within the grant term, but, if needed, a one year extension is allowed upon request.

The County's estimate of the project cost is \$430,000.00. The FIND estimated total project cost \$410,000.00 shown on the resolution, is less because FIND disallows in-house costs such as project management, architectural and engineering costs and bidding and contracting costs from the grant

program. Thus the maximum FIND grant is 50% of their allowed project costs. The county match provides the remaining funding sufficient to complete the project.

As part of its application process, FIND requires that a resolution be adopted in substantially the form of this resolution by the agency seeking FIND grant funds. Amendments will only be made in conformance with this resolution where no additional matching funds or other County funds are encumbered, otherwise Board approval will be required to make amendments to the grant.

RESOLUTION AUTHORIZING SUBMITTAL OF A GRANT APPLICATION TO THE FLORIDA INLAND NAVIGATION DISTRICT, (FIND) WATERWAYS ASSISTANCE PROGRAM FOR \$205,000.00 WITH MATCHING COUNTY FUNDS OF \$225,000.00 **FROM** THE **FLORIDA BOATING IMPROVEMENT** VESSEL FEE REGISTRATION ALLOCATION FUND FOR WET-SLIP RENOVATIONS AT HOMESTEAD BAYFRONT MARINA AND FURTHER AUTHORIZING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO RECEIVE AND EXPEND FUNDS, AND EXECUTE GRANT AWARD AGREEMENTS, CERTAIN AMENDMENTS AND OTHER DOCUMENTS AS REQUIRED BY FIND AND THE GRANT UPON REVIEW AND FINAL APPROVAL

WHEREAS, this Board desires to accomplish the purpose outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

WHEREAS, Miami Dade County is interested in carrying out the following described project for the enjoyment of the citizenry of Miami-Dade County and the State of Florida:

Project Title: Homestead Bayfront Marina Wet-slips Renovations

Total Florida Inland Navigation District (FIND) Estimated Cost: \$410,000.00

Brief Description of Project: Renovations of Wet-slips at Homestead Bayfront Marina;

and

WHEREAS FIND financial assistance is required for the project mentioned above; and

WHEREAS, as part of its application process, FIND requires that a resolution be adopted by the agency seeking FIND grant funds in substantially the form of this resolution,

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board authorizes the submittal of a grant application for \$205,000.00 to FIND, Waterways Assistance Program with a County match of \$225,000.00 from the Florida Boating Improvement Vessel Fee Registration Allocation Fund,

AND, BE IT FURTHER RESOLVED that said Miami-Dade County make application to the Florida Inland Navigation District in the amount of up to 50% of the FIND estimated cost in behalf of Miami-Dade County,

AND, BE IT FURTHER RESOLVED by Miami-Dade County that it certifies to the following:

- 1. That it will accept the terms and conditions set forth in FIND Rule 66B-2 F. A. C. and which will be a part of the Project Agreement for any assistance awarded under the proposal.
- 2. That it is in complete accord with the proposal for Homestead Bayfront Marina Wet-slips Renovations and that it will carry out the Program in the manner described in the proposal and any plans and specifications attached thereto unless prior approval for any change has been received from the District.
- 3. That it has the ability and intention to finance its share of the cost of the project and that the project will be operated and maintained at the expense of said Miami-Dade County for public use.
- 4. That it will not discriminate against any person on the basis of race, color or national origin in the use of any property or facility acquired or developed pursuant to this proposal, and shall comply with the terms and intent of the Title VI of the Civil Rights Act of
