



**Subject:** Contract Award Recommendation in the Amount of \$690,514.11 to RG Underground Engineering, Inc. for the People's Transportation Plan Project Entitled Drainage Improvement Project, located within Commission District 8; and Authorizing the Use of Charter County Transportation System Surtax Funds for such purposes

## Recommendation

The attached Contract Award Recommendation for the People's Transportation Plan (PTP) project entitled *Drainage Improvement Project*, located within Commission District 8 (Project MCC 7040 Plan - CICC 7040-0/07 Request for Price Quotation (RPQ) No. 20140086) in the amount of \$690,514.11 to RG Underground Engineering, Inc., was prepared by the Public Works and Waste Management Department (PWWM) and is recommended for approval by the Board of County Commissioners (BCC).

This Contract Award Recommendation is placed for Committee review pursuant to Miami-Dade County Code Section 29-124(f). This Contract Award Recommendation may only be considered by the BCC if the Citizens' Independent Transportation Trust (CITT) has forwarded a recommendation to the BCC prior to the date scheduled for BCC consideration or forty-five (45) days have elapsed since the filing with the Clerk of the Board of this contract award recommendation. If the CITT has not forwarded a recommendation and forty-five (45) days have not elapsed since the filing of this award recommendation, I will request a withdrawal of this item.

## Scope

The work to be performed under this Contract includes drainage improvements along SW 122 Avenue, from SW 104 Street to SW 105 Terrace; The Crossings at SW 132 Avenue, from SW 119 Street to SW 117 Street; and SW 134 Avenue, from SW 108 Street to SW 108 Circle South in Commissioner Daniella Levine Cava's District 8.

## Fiscal Impact/Funding Source

The fiscal impact will be approximately \$690,514.11 and will be funded from the Charter County Transportation Sales Surtax Bond Sale Proceeds and the Stormwater Utility. The base contract amount is \$612,512.60, with the total amount being inclusive of contingency and dedicated allowance amounts. There is no fiscal impact to operations or maintenance.

The proposed improvements qualify under the allowable work categories included in the PTP Neighborhood Improvements Section. The funding index codes for this Project are CPEPTP708DRN.99111 (FY 2013-14 Adopted Capital Budget Project No. 6037700) and CPE316PEARTR.99111 (FY 2013-14 Adopted Capital Budget Project No. 607800).

## Delegation of Authority

No additional authority is being requested within the body of this Contract.

**Track Record/Monitor**

RG Underground Engineering, Inc. has performed work for PWWM at a satisfactory level. The Capital Improvements Information System (CIIS) database lists 21 awarded construction contracts for each of the following departments:

- one (1) from Aviation,
- eight (8) from Water and Sewer, and
- twelve (12) from PWWM.

The referenced database also lists a total of 20 contractor performance evaluations with an overall performance rating of 3.2 (satisfactory performance) out of a possible 4.0 (superior performance) rating. The Small Business Development Division (SBD) History of Violation's report lists no violations for this contractor.

According to the Florida Department of State, Division of Corporations, the RG Underground Engineering, Inc., Company Principal is Ricardo Gonzalez and the Company's address is listed as 6271 SW 139 Avenue, Miami, Florida 33183.

Following PWWM's standard operating procedures after award of this Contract, a pre-construction meeting will be scheduled. The person responsible for all PTP projects in PWWM is Mr. Alejandro Martinez-Esteve, RA, LEED AP, Manager, Capital Improvements Section. Following completion of the award process, the project will be assigned to Mr. Leo Salguiero, Project Manager, for the day-to-day responsibilities.

**Background**

As part of the PTP Neighborhood Improvements initiative, PWWM continues to take advantage of various contracting mechanisms such as the Miscellaneous Construction Contracting process available under the MCC 7040 Program. Through this process, PWWM forwards a Request for Price Quotation by way of facsimile transmission to a pool of pre-qualified Community Small Business Enterprise (CSBE) contractors for the respective trade. Additionally, all solicitations are available on-line through the Miami-Dade County portal under the "Procurement Solicitations" link. The project's award evaluation is based upon the bid submitted by the lowest responsive, responsible bidder for the project.

PWWM staff determined that the scope of work for this project qualified for a CSBE set-aside (Levels I, II, and III). A Community Workforce Program Goal is not applicable to this project. On June 26, 2014, PWWM forwarded RPQ No. 20140086 utilizing the MCC 7040 Plan - CICC 7040-0/07 Contract to a list of 225 pre-qualified firms. A total of two (2) firms purchased contract documents and seven (7) firms proffered a bid.

On July 30, 2014, RG Underground Engineering, Inc., proffered the lowest responsive and responsible base bid of \$612,512.60, ten (10) percent above the County's cost estimate. The second lowest bidder, Acre Engineering Construction, Inc., proffered a base bid of \$645,966.00, 16 percent above the County's cost estimate. The third lowest bidder, E & M Equipment Corp., proffered a base bid of \$664,760.75, 20 percent above the County's cost estimate.

Based on the results of the solicitation, PWWM issued a recommendation for award on August 14, 2014 for RPQ No. 20140086 to RG Underground Engineering, Inc., with the stipulation that approval for this project must be obtained from the CITT and the BCC.

The work to be accomplished for this project consists of, but is not limited to, furnishing all supervision, labor, required materials, tools, and equipment required to provide construction and installation of drainage structures, french drains, miscellaneous drainage improvements, grading, sodding, and miscellaneous roadway restoration including the construction of concrete curb and gutters, and sidewalks in accordance with the construction plans.


