## Recommendation

## **Background**

The Agricultural Practices Advisory Board consists of 13 members representing a variety of agricultural industries. The Board of County Commissioners is required to fill vacancies on the Agricultural Practices Advisory Board under Section 2-935 of the Code of Miami-Dade County. Each organization listed in Section 2-933 shall submit for Board review at least one nominee for a vacancy to include the nominee's resume and the minutes of the meeting at which the nominee was selected. That documentation is attached.

## Vegetable Industry No. 2 Representative


The Dade County Farm Bureau recommended the reappointment of Tommy Vick at the November 4, 2014 Board of Directors meeting. Mr. Vick is the owner of V&B Farms, established in 2009, and is the previous owner of Tom Vick Farms. Mr. Vick began farming as a 4-year old with Vick Farms Palms, and over the years worked for Daigle Farms, Super-Six Farms and Richard Borek Farms prior to owning Tom Vick Farms from 1994 to 2009. He has participated in the Homestead Florida City Chamber of Commerce's "Green Committee" event, the Miami International Agriculture & Cattle Show, and the Homestead Centennial Celebration, and has been a member of the Dade County Farm Bureau, Dade County Agri-Council, and Future Farmers of America. Mr. Vick is a 2001 graduate of South Dade Senior High School.

The term for this re-appointment begins January 1, 2015 and ends December 31, 2018.

Vice President Ivonne Alexander called the meeting to order at 12:05pm.

Ivonne Alexander asked all BOD to update their contacts. She welcomed the new Board of Directors and they all introduced themselves.

Thomas Bullis Jr. of Bullis Bromeliads introduced himself. Margie Pikarsky of Bee Heaven Farms introduced herself. Dale Machesic of South Dade News Leader introduced himself. Aaron Palmateer of UF/TREC introduced himself. Pedro SiFuentes of SiFuentes Farms introduced himself.

Eddie Aponte gave a Ag Patrol Report. He went over the October statistics. There were 156 cases for the month. Aponte reported 12 burglaries, some of which included a back-ho was stolen along with an engine from a Lychee grove. Another large item was stolen from Costa farms. There were only 2 thefts for the month, one of which was a flatbed trailer. There were 16 civil cases most of which involved vehicle. There were 17 animal related calls. More than half involved dead horses and other livestock.

Tom MacVicar gave a water report. There was a meeting 3 weeks ago. He met with the Army Corps of Engineers and met with the SFWMD and no one has come up with an alternative solution to the water issues. Tom MacVicar came up with a solution but it was not approved by the Army Corps of Engineers or the SFWMD. The Army Corps of Engineers would not open the s-197. There is a very important meeting coming up November 17<sup>th</sup>. Everglades National Park has been fairly supportive. The Corps will not open the s-197 because of environmental opposition. MacVicar said by the December board meeting there should be more information as to what will happen.

Charles LaPradd gave a County AG Manager report. The County announced May 15<sup>th</sup> as "Ag Day." LaPradd discussed Raising Fields as a new effort to raise fields. There is a website called raising fields.org that LaPradd urges the board to visit to become more informed. Charles LaPradd discussed the farm

Debble Brady discussed having a new BOD Orientation. She asked the new directors to please send their availability to her and a date will be set via email.

Ivonne Alexander discussed committees. An email will be sent out discussing this.

Alexander announced to members, that as of June 2014 Tom Vick is not serving on the Board, he can still serve on the AG Practices Advisory Board. Larry Dunagan made a motion to allow Tommy Vick to serve on the Ag Practices Board. Phil Marraccini seconded the motion. Motion carried.

A vote needed to take place to see if the BOD would like to combine the Christmas party with FNGLA. Tom Rieder made a motion to combine the DCFB party with FNGLA. Jerry Frye seconded the motion. Motion carried.

Phil Marraccini made an announcement that the Dade AGRI Council will be having a Golf Tournament on Jan. 9<sup>th</sup> and the Dade AGRI Council Farm Tour will be February 11<sup>th</sup>.

Charles LaPradd announced that Farm City Week will take place November 20<sup>th</sup> at the Stephen P. Clark Center. Farm City Week is about bringing the farm to the city dwellers. Robert is Here will set up a Farmer's Market. DCFB Women's Committee will participate.

Ivonne Alexander adjourned the meeting at 1:21pm.

WHEREAS, Sections 2-931 through 2-936 of the Code of Miami-Dade County provide for the creation, composition, terms, purpose and duties of the Agricultural Practices Advisory Board; and

WHEREAS, Section 2-933 of the Code of Miami-Dade County specifically provides for the designated organizations to recommend at least one nominee; and

WHEREAS, Mr. Tommy Vick completed his first term as the Vegetable Industry Representative 2 on the Agricultural Practices Advisory Board and is eligible for reappointment for a second term; and
