RESOLUTION AMENDING RESOLUTION NO. R-17-07 TO CORRECT THE CODESIGNATION OF SW 92ND AVENUE FROM CORAL WAY (SW 24TH STREET) TO BIRD ROAD (SW 40TH STREET) FROM BEING "AGUSTIN F. VELASCO AVENUE" TO BEING "AGUSTIN C. VELASCO AVENUE"

WHEREAS, Agustin C. Velasco was born on September 26, 1923, in San Nicolas de Bari in Cuba; and

WHEREAS, Agustin C. Velasco's idea of operating a bank in Miami started when he came to Miami in 1961, fleeing the inequities of communist Cuba; and

WHEREAS, many years passed before he and a banking associate could seriously discuss the opening of a small bank, but by the 1970s they felt the timing and the opportunity were right for the project; and

WHEREAS, Agustin C. Velasco's commitment and dedication to the expansion of the Interamerican Bank and the creation of innovative programs helped him gain respect within our community; and

WHEREAS, Agustin C. Velasco, from these humble beginnings and hard work, became a pillar of the Hispanic community and his reputation as a banker was impeccable; and

WHEREAS, by creating new branches to accommodate the South Florida community and continually envisioning new programs, he ensured that Interamerican Bank will remain to serve its community; and

WHEREAS, Interamerican Bank, a local community bank, has been an integral part of Miami-Dade County since 1976, with four current locations in Miami-Dade County, including one on the southeast corner of Coral Way and SW 92nd Avenue; and

WHEREAS, Agustin C. Velasco recently passed away on May 30, 2014; and

WHEREAS, on January 25, 2007, this Board approved Resolution No. R-17-07, codesignating SW 92nd Avenue from Coral Way to Bird Road in honor of Agustin C. Velasco; and

WHEREAS, Agustin C. Velasco's middle initial was incorrectly identified in Resolution No. R-17-07, identifying the codesignation as "Agustin F. Velasco Avenue"; and

WHEREAS, Bird Road was also incorrectly identified in Resolution No. R-17-07, identifying the road as SW 42nd Street; and

WHEREAS, the Board now desires to correct the middle initial and street number of this codesignation; and

WHEREAS, SW 92nd Avenue from Coral Way (SW 24th Street) to Bird Road (SW 40th Street) is, and was at the time the Board approved Resolution No. R-17-07, a Miami-Dade County road located in unincorporated Miami-Dade County; and

WHEREAS, this proposed amended codesignation is located in County Commission District 10,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Having considered this matter at a public hearing, amends Resolution No. R-17-07 to correct the codesignation of SW 92nd Avenue from Coral Way (SW 24th Street) to Bird Road (SW 40th Street) from being "Agustin F. Velasco Avenue" to being "Agustin C. Velasco Avenue".

Section 2. Directs the Clerk of the Board to send certified copies of this resolution to the United States Postal Service, the Traffic Signals and Signs Division of the Public Works and Waste Management Department, the Development Services Division of the Regulatory and Economic Resources Department, the Miami-Dade Police Department, and the Miami-Dade Fire Rescue Department.

The Prime Sponsor of the foregoing resolution is Senator Javier D. Souto. It was offered by Commissioner , who moved its adoption. The motion was seconded by Commissioner and upon being put to a vote, the vote was as follows:
