PRESIDENT BARACK OBAMA'S GRANT PROPOSAL OF \$75 MILLION OVER THE SPAN OF THREE YEARS TO MATCH STATE AND LOCAL FUNDING FOR POLICE OFFICER BODY-WORN CAMERAS

WHEREAS, 76 percent of Americans believe that police officers should be required to wear body cameras, according to a 2014 NBC Marist Poll; and

WHEREAS, an increasing number of police departments have adopted the requirement that its police officers wear body cameras, according to a 2014 report by the Office of Community Oriented Policing Services, United States Department of Justice ("DOJ report"); and

WHEREAS, some police chiefs report that police officer body-worn cameras help build and improve positive police-community relationships, according to the DOJ report; and

WHEREAS, such relationships improve because police officer body-worn cameras help defuse tensions during police officer encounters with the public, according to the DOJ report; and

WHEREAS, police officers wearing body cameras had a 60 percent reduction in use of force incidents, according to a 2013 study of the Rialto, California Police Department; and

WHEREAS, the Rialto study reported that police officers not wearing body cameras experienced twice as many use of force incidents; and

WHEREAS, according to the DOJ report, police officer body-worn cameras greatly benefit police officers by shielding them from unfounded citizen complaints; and

WHEREAS, police officers wearing body cameras experienced an 88 percent decline in the total number of complaints, according to the Rialto study; and

WHEREAS, a 2013 study of the Mesa, Arizona Police Department also reported a decline in complaints, with 40 percent fewer complaints for police officers wearing body cameras; and

WHEREAS, police officers not wearing body cameras experienced nearly three times more complaints than police officers wearing body cameras, according to the Mesa study; and

WHEREAS, President Barack Obama announced a grant proposal of \$263 million for police training and police officer body-worn cameras; and

WHEREAS, within the \$263 million grant proposal, a total of \$75 million over the span of three years would be used for police officer body-worn cameras, helping pay for more than 50,000 body cameras; and

WHEREAS, the \$75 million funding would provide a 50 percent match to state and local law enforcement agencies that purchase police officer body-worn cameras; and

WHEREAS, this Board's Fiscal Year 2014-15 budget includes \$1 million for the purchase of police officer body-worn cameras for use by Miami-Dade County police officers; and

WHEREAS, the implementation and use of police officer body-worn cameras has been delayed until the Miami-Dade County Mayor provides a report on the benefits and concerns associated with such cameras; and

WHEREAS, concern over the relationship between police and minority communities has led to recent discussions of the advantages and disadvantages of police officer body-worn cameras; and

WHEREAS, President Obama held a series of meetings with law enforcement personnel, civil rights leaders and Cabinet members to discuss methods of improving the relationship between police and minority communities; and

WHEREAS, the funding of police officer body-worn cameras is an effective method of improving such relationships, not only for the public, but also for law enforcement; and

WHEREAS, Congress should approve President Obama's grant proposal for police officer body-worn cameras,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Urges Congress to approve President Barack Obama's grant proposal of \$75 million over the span of three years to match state and local funding for police officer bodyworn cameras.

<u>Section 2.</u> Directs the Clerk of the Board to transmit a certified copy of this resolution to members of the Florida Congressional Delegation.

Section 3. Directs the County's federal lobbyists to advocate for the legislative action set forth in Section 1 above, and authorizes and directs the Office of Intergovernmental Affairs to amend the 2015 Federal Legislative Package to include this item.

The Prime Sponsor of the foregoing resolution is Chairman Jean Monestime and the Co-Sponsor is Commissioner Sally A. Heyman. It was offered by Commissioner
