Advance Notice of Events in Parks - Directive 142359

At the November 5, 2014 Board of County Commissioners (Board) meeting, the Board approved Resolution No. R-1009-14 (Attachment A), as amended, sponsored by Senator Javier D. Souto directing the County Mayor or County Mayor's designee to: a) provide each District Commissioner with advance written notice of each permitted event with an expected attendance of over 100 persons to be held in a County park located within such Commissioner's district; and b) provide the Cultural Affairs and Recreation Committee (Committee) with advance notice via an oral report at each Committee of all permitted events scheduled to be held in County parks with an expected attendance of over 100 persons.

The Parks, Recreation and Open Spaces Department (PROS) maintains a log of scheduled events and provides each County Commissioner's office with a monthly listing of events occurring within County parks in their District. Attachment B is a sample of the log for Commission District 10 January 2015 events. The listing includes the name of the event, event description, date of the event, expected attendance and the group or person conducting the event. Activities in parks such as shelter rentals, picnics, and weddings are not listed in the report. PROS will continue this procedure to advise Commissioners of events in their parks. PROS will also provide the Committee a monthly oral report of events in parks.

WHEREAS, being informed ahead of time as to these large events in County parks would allow Commissioners to provide better outreach and services to their constituents regarding these events, to assist with coordination of these events, and to anticipate and help with addressing any concerns with logistics or otherwise of any particular event in a County park; and

WHEREAS, specifically, this Board desires to be informed in advance, both individually as to events at parks within each Commissioner's district >> for which a permit is issued pursuant to Administrative Order 8-3 ("Permitted Event")<<1 as well as collectively via an oral report
