Directive 142776 - Report on the Feasibility of Increasing Affordable Housing for the

Elderly

On February 3, 2015, the Miami-Dade County Board of County Commissioners (Board) adopted Resolution No. R-143-15 directing the County Mayor or County Mayor's designee to submit a report on the feasibility of increasing affordable housing for the elderly through the utilization of County affordable housing funds.

#### Background

Public Housing and Community Development (PHCD) reviewed its Request for Application (RFA) process from approximately 1989 to 2014, including the following funding sources: Documentary Surtax Program (Surtax), Community Development Block Grant (CDBG), State Housing Initiatives Partnership Program (SHIP), Neighborhood Stabilization Program (NSP), and Home Investment Partnerships Program (HOME). PHCD has funded 231 affordable projects with 25,400 units (excluding Public Housing Preservation projects). There were 3,930 units (approximately 15 percent) designated as elderly housing as listed on Attachment A. Further narrowing the target timeframe to 2011 through 2014, PHCD has funded 52 affordable projects with 4,637 units (excluding Public Housing Preservation projects). From these units, 582 units (approximately 13 percent) were designated as elderly housing.

Miami-Dade County through its Internal Services Department (ISD) and PHCD continued to rehabilitate and develop new affordable elderly housing units. ISD using the General Obligation Bond Program (GOB) completed the development of six (6) elderly projects totaling 384 units. There are currently three (3) projects underway with an additional 226 units in various stages of construction. PHCD rehabilitated four (4) public housing elderly developments totaling 548 units, and added a new public housing development, Collins Park Apartments, with 124 new units. PHCD have several other projects that are in various stages of obtaining funding that will produce approximately 551 additional new units of public housing, affordable housing, and rehabilitate another 583 existing units for elderly residents.

The conventional public policy indicator of housing affordability in the United States is the percent of income spent on housing. Housing expenditures exceeding 30 percent of household income historically have been viewed as an indicator of a housing affordability problem. The 2013 U.S. Census data illustrates the housing expense cost burden for Miami-Dade County (Attachment B), indicating that the elderly population is just as rent burdened as the families.

This certainly suggests that more needs to be done to address affordable housing for the aging population, especially in Commission Districts with the highest needs. Attachment B illustrates that districts 10, 6, 11, and 4 have in that order with 10 being the most needy. According to the 2013 Shimberg Study<sup>1</sup>, "Statewide, households headed by persons age 55 – 74 make up 20.3 percent of cost burdened renters with another 8.6 percent of cost burdened households with a householder age 75 or older. Table 3.4 illustrates this figure regionally. At the highest, 38 percent of cost burdened households in the Pasco/Pinellas region and 34 percent in the Miami-Dade/Monroe region are headed by persons age 55 and over."

# Possible Responses to Need

- 1. Adapt the RFA process to award a development that can provide additional elderly/senior housing
  - a. Award additional points to developers who propose projects for elderly households.
  - b. Award additional points to developers who provide a plan for activities and services for the proposed elderly/senior residents in their project.
  - c. Set aside a certain amount of funding specifically for elderly housing.
- 2. Make County-owned vacant land available to developers who develop elderly/senior housing
  - a. Land will be either sold to the developer with a County Deed covenant for the development of affordable elderly/senior housing.
  - b. Long-term leases at the same rent is also an option.

Options 1 and 2 could be further linked to prioritization of resources to areas of greatest need as shown in Attachment B and referenced above.

- 3. Use of Section 8 Project-Based Vouchers (PBV) for incentives to develop additional elderly projects. This can be done whether the project is privately developed, County developed or via a joint partnership development:
  - a. Project-based vouchers are funded by USHUD to PHCD under our Annual Contributions Contract (ACC). PHCD can use up to 20 percent of its housing choice vouchers for project based vouchers.
  - b. PHCD may provide project-based assistance for existing housing that does not need rehabilitation, and for newly constructed or rehabilitated housing.
  - c. For elderly housing, up to 100 percent of units may have project-based voucher assistance.
  - d. PHCD may enter into a Housing Assistance Program (HAP) contract with an owner for an initial term of up to 15 years and an extension of the initial term of up to 15 years. PHCD may agree to an extension at the time of initial HAP contract execution or any time before the expiration of the contract.
- Monitor USHUD's website for grant opportunities and communicate various opportunities to developers (i.e. Section 202 Program).
- 5. PHCD may continue to partner with ISD to develop (design and construct) additional elderly rental housing, which can be a cost effective use of funding and produce a lower per unit cost, as described in Attachment C.
- Monitor foreclosure or distressed multi-family rental properties to purchase, rehabilitate and designate for elderly housing.

#### Conclusion

In August 2014, the RFA for State Apartment Incentive Loan (SAIL) funding was issued by the Florida Housing Finance Corporation, where funding was set aside specifically for elderly developments. The total funding amount for SAIL is estimated at \$64,408,800.00 with \$17,578,800.00 (approximately 27 percent) set aside for elderly developments. This demonstrates that the State has determined that there is a need for elderly housing. Based on the information gathered, it is clear that a more proactive approach to further encourage development initiatives for elderly housing is needed within Miami-Dade County. To that end, PHCD will develop guidelines and procedures to achieve this goal. The Affordable Housing Guidelines are to be updated with the various proposed solutions discussed in this report.

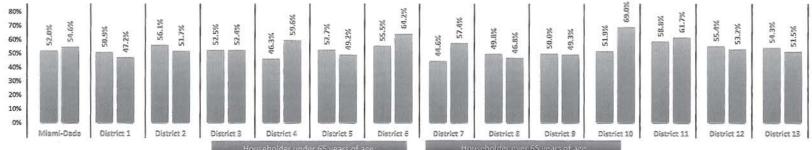
