Pursuant to R-636-14, the OCA completed background research regarding BCC Agenda Item 11(A)4, Resolution waiving by a two-thirds vote of the members present the term limit restriction for County Board Members as specified in Section 2-11.28.2 of the Code of Miami-Dade County and authorizing the re-appointment of Paul Schwiep to the Citizens' Independent Transportation Trust and the following information was found pursuant to the Miami-Dade County Clerk of Courts public records search:

- September 22, 1999- Hospital Claim of Lien- Baptist Hospital of Miami- \$454; and
- May 10, 2006- Hospital Claim of Lien- Public Health Trust of Dade County- \$8,972.87.
