RESOLUTION NO. _____

RESOLUTION DIRECTING THE COUNTY MAYOR OR
MAYOR'S DESIGNEE TO ESTABLISH A SISTER PARK
RELATIONSHIP WITH FERNANDO COSTA PARK IN
UBERABA, BRAZIL WITHIN BUDGETED FUNDS AND TO
REPORT TO THE BOARD ON THE STATUS OF THE
ESTABLISHMENT OF SAID SISTER PARK RELATIONSHIP

WHEREAS, pursuant to Resolution No. R-141-14, this Board directed the County Mayor or Mayor's designee to establish a Sister Parks and Cultural Facilities Program under which Miami-Dade County parks and cultural facilities are paired with willing parks and cultural facilities in other countries so as to foster cultural and informational exchanges between the paired facilities; and

WHEREAS, Fernando Costa Park is a public park in Uberaba, Brazil that was founded in 1929 by the then-Secretary of Agriculture, Fernando Costa, as a place for exhibitions related to animal husbandry and has, since its founding, held the reverence of the Brazilian public; and

WHEREAS, Fernando Costa Park has hosted major animal husbandry events, including the XV World Brahman Congress in 2010, which attracted thousands of participants and visitors from around the globe, including from all six permanently inhabited continents; and

WHEREAS, in addition to the XV World Brahman Congress, Fernando Costa Park has attracted other major international agricultural events, such EXPOZEBU 2015—the biggest exposition of zebu cattle in the world—which also drew thousands of visitors from around the world; and

WHEREAS, a partnership between a Miami-Dade County park and Fernando Costa Park would foster informational exchanges that would be beneficial to Miami-Dade County, particularly insofar as Miami-Dade County has held similar events to those held at Fernando Costa Park (e.g., the Miami International Agriculture, Horse and Cattle Show held annually at Tropical Park) and seeks to continue to hold such events in the future,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. The County Mayor or Mayor's designee is directed to establish, within budgeted or otherwise available funds, a Sister Park relationship with Fernando Costa Park in Uberaba, Brazil and the appropriate Miami-Dade County park pursuant to Resolution No. R-141-14.

Section 2. The County Mayor or Mayor's designee shall prepare a status report to the Board on its implementation of the directive set forth in Section 1. To the extent the County Mayor or Mayor's designee are unable to fully implement the directive set forth in Section 1 within budgeted or otherwise available funds, the County Mayor or Mayor's designee's report shall advise this Board of the extent to which the directive can be accomplished within budgeted funds and what additional funding is necessary to fully implement the directive. The County Mayor or Mayor's designee shall provide the report to this Board within 180 days of the effective date of this resolution and shall place the completed report on an agenda of the Board pursuant to Ordinance No. 14-65.

The Prime Sponsor of the foregoing resolution is Senator Javier D. Souto. It was offered by Commissioner _____, who moved its adoption. The motion was seconded by Commissioner _____ and upon being put to a vote, the vote was as follows:
