RESOLUTION DECLASSIFYING DESIGNATED FACILITIES
OF THE PUBLIC HEALTH TRUST THAT WERE FORMERLY
OPERATED BY THE PUBLIC HEALTH TRUST AS THE
JACKSON NORTH MATERNITY CENTER, LOCATED AT
14701 NW 27 AVENUE, OPA-LOCKA, FLORIDA 33054

WHEREAS, pursuant to Chapter 25A of the Code of Miami-Dade County (the “Code”), the Public Health Trust of Miami-Dade County (the “Trust”) was created as an agency and instrumentality of the County responsible for the governance, operation and maintenance of Jackson Memorial Hospital and other Designated Facilities (as such term is defined in Chapter 25A of the Code); and

WHEREAS, Chapter 25A-2(a) of the Code provides that by resolution the Board of County Commissioners (the “Board”) may designate certain County property as Trust Designated Facilities and that this Board may also declassify and remove from Trust jurisdiction Designated Facilities which may have been previously designated; and

WHEREAS, in accordance with Chapter 25A-2(a) of the Code, this Board now desires to declassify and remove from the jurisdiction of the Trust those Designated Facilities comprised of three (3) parcels of real property which were formerly known as and operated by the Trust as the Jackson North Maternity Center, located at 14701 NW 27 Avenue, Opa-Locka, Florida 33054 and to return such real property to the jurisdiction of the County; and

WHEREAS, Jackson North Maternity Center is located in Commission District 1; and

WHEREAS, the Trust does not have a strategic need for the real property comprising Jackson North Maternity Center,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. The foregoing recitals are incorporated in this resolution and are approved.

Section 2. Pursuant to Section 25A-2(a) of the Code, this Board declassifies Jackson North Maternity Center, located at 14701 NW 27 Avenue, Opa-Locka, Florida 33054 and removes such real property from the jurisdiction of the Trust.

Section 3. The folio numbers for the declassified parcels of real property comprising Jackson North Maternity Center are: 08-2122-026-0010; 08-2122-025-0580 and 08-2122-025-0590.

The Prime Sponsor of the foregoing resolution is Commissioner Barbara J. Jordan. It was offered by Commissioner _____, who moved its adoption. The motion was seconded by Commissioner _____ and upon being put to a vote, the vote was as follows:


