RESOLUTION DIRECTING THE COUNTY MAYOR OR THE COUNTY MAYOR'S DESIGNEE TO HAVE THE SEAPORT DEPARTMENT AND THEMIAMI-DADE **AVIATION** DEPARTMENT WORK WITH THE CRUISE LINES TO DEVELOP A PLAN TO ESTABLISH A CRUISE VISITOR CENTER AT MIAMI INTERNATIONAL AIRPORT, EITHER FOR INDIVIDUAL CRUISE LINES OR MULTIPLE CRUISE LINES, FOR PROCESSING OF CRUISE LINE PASSENGERS UTILIZING MIAMI INTERNATIONAL AIRPORT FOR THE PURPOSE OF SAILING ON A CRUISE FROM PORTMIAMI; AND DIRECTING THE COUNTY MAYOR OR THE COUNTY MAYOR'S DESIGNEE TO SUBMIT A REPORT REGARDING THE PLAN TO ESTABLISH A CRUISE VISITOR CENTER AT MIAMI INTERNATIONAL AIRPORT WITHIN 60 DAYS

WHEREAS, Miami International Airport and PortMiami are Miami-Dade County's largest economic engines and fuel growth in tourism and trade; and

WHEREAS, PortMiami welcomed nearly 4.8 million cruise passengers in fiscal year 2014 and continues to expand as the world's leading cruise port; and

WHEREAS, the majority of passengers sailing from PortMiami who arrive by air travel originate at Miami International Airport; and

WHEREAS, several cruise lines currently lease space at Miami International Airport for processing of their cruise passengers and others have expressed interest in leasing similar space; and

WHEREAS, the Board of County Commissioners (the "Board") believes that the establishment of a cruise visitor center ("Cruse Visitor Center") will increase tourism and trade by providing a positive customer service experience and a convenient and efficient means for processing cruise line passengers and their luggage from Miami International Airport directly to PortMiami,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. The foregoing recitals are incorporated in this resolution and are approved.

Section 2. The Board hereby directs the County Mayor or the County Mayor's designee to have the Seaport Department and the Miami-Dade Aviation Department work with the cruise lines to develop a plan to establish a Cruise Visitor Center at Miami International Airport, either for individual cruise lines or multiple cruise lines, for processing of cruise line passengers utilizing Miami International Airport for the purpose of sailing on a cruise from Port Miami. The plan shall include: (1) identification of available space at Miami International Airport; (2) the costs associated with establishing, managing and operating a Cruise Visitor Center; (3) identification of potential funding sources; (4) a list of interested cruise lines; (5) a timeline for development and commencement of operations; and (6) identification of other relevant entities interested in participating (e.g., Greater Miami Convention & Visitors Bureau and Miami Hotel Association).

Section 3. The Board further directs the County Mayor or the County Mayor's designee to submit a report regarding the plan to establish a Cruise Visitor Center at Miami International Airport to this Board within 60 days of the effective date of this resolution. In the event that the County Mayor or the County Mayor's designee concludes that such plan is not feasible, the reasons for such conclusion shall be included in the report. The completed report shall be placed on an agenda of the Board pursuant to Ordinance No. 14-65.
