**Subject:** Resolution approving the Waiver of Plat of JOHN C. CAREY AND SABYLISZT B. CAREY

## **Recommendation**

The following waiver of plat is hereby submitted for consideration by the Board of County Commissioners for approval. This plat is bounded on the north approximately 350 feet south of SW 72 Street, on the east approximately 250 feet west of SW 49 Avenue, on the south by SW 74 Street, and on the west approximately 900 feet east of SW 52 Avenue. The Miami-Dade County Plat Committee, comprised of representatives from the Florida Department of Transportation, the Florida Department of Health, the Miami-Dade County School Board and Miami-Dade County Departments of Fire Rescue, Parks, Recreation and Open Spaces, Regulatory and Economic Resources (RER), Public Works and Waste Management (PWWM), and Water and Sewer, recommends approval of this waiver of plat.

## **Scope**

This waiver of plat is located in Commission District 7, which is represented by Commissioner Xavier L. Suarez.

## **Fiscal Impact/Funding Source**

There is no associated fiscal impact to Miami-Dade County with the approval of this waiver of plat; all improvements are in place.

## **Track Record/Monitor**

The Development Services Division of RER administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P. L. S.

RESOLUTION APPROVING THE WAIVER OF PLAT OF JOHN C. CAREY AND SABYLISZT B. CAREY, D-23290, LOCATED IN THE NORTHEAST 1/4 OF SECTION 31, TOWNSHIP 54 SOUTH, RANGE 41 EAST (BOUNDED ON THE NORTH APPROXIMATELY 350 FEET SOUTH OF SW 72 STREET, ON THE EAST APPROXIMATELY 250 FEET WEST OF SW 49 AVENUE, ON THE SOUTH BY SW 74 STREET, AND ON THE WEST APPROXIMATELY 900 FEET EAST OF SW 52 AVENUE)

**WHEREAS**, John C. Carey and Sabyliszt B. Carey, have this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a portion of Lot 1 of "Correction of Map of the Subdivision of the Property of A. E. Kingsley" according to the plat thereof, as recorded in Plat Book 1, at Page 41, of the public records of Miami-Dade County, Florida, lying and being in the Northeast 1/4 of Section 31, Township 54 South, Range 41 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that said waiver of plat is hereby approved; that the property has been found to be in compliance with Chapter 28, Subdivisions, of the Miami-Dade County Code; that approval of this waiver of plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this waiver of plat conforms to those requirements.




