

Subject: Report on Public Housing Lease Enforcement Efforts – Directive 151658

October 20, 2015
Agenda Item No. 2B5

At the April 21, 2015 Board of County Commissioners (Board) meeting, Commissioner Audrey M. Edmonson requested that the Public Housing and Community Development Department (Department) provide a report with the steps taken by the Department to enforce the Public Housing Lease. The Board adopted the amended Resolution No. R-337-15 (Resolution) requesting that the report include the following information:

- Total number of evictions and basis for evictions for the period;
- Recommendations on steps to improve current lease efforts;
- Recommendations on any legislative action that the Board can take regarding lease enforcement; and
- Conduct informal workshops with all Public Housing residents regarding lease, community policies, laws and regulations.

In accordance with the Resolution, the Department has initiated actions to improve its efforts to ensuring enforcement of its Conventional Public Housing Dwelling Lease Agreement (Dwelling Lease) and Public Housing Community Policies (Community Policies).

Between March 12, 2015 and May 15, 2015, a total of 57 informal workshops were held with residents throughout Public Housing sites managed by the County to review and discuss the Dwelling Lease and Community Policies that residents sign at the time of move-in. A schedule of workshops held during the above period is provided as Attachment A. Lease enforcement workshops will also be held at Public Housing developments not directly managed by the County.

In addition, a series of meetings have been held with the Department's Asset Management on-site staff to stress the importance of holding residents accountable and enforcing the Dwelling Lease and Community Policies to improve the overall environment of Public Housing sites.

Since completing the lease enforcement workshops in May 2015, site staff has been more vigilant and assertive in enforcing the Dwelling Lease and issuing notices to residents who have been found to be in violation. Between March 1, 2015 and June 30, 2015 alone, at least 200 actions, including evictions, have been initiated in relation to Dwelling Lease and Community Policies violations, in comparison to only 38 for the same period in 2014 (Attachment B). Additionally, as a result of the actions initiated by the Department in 2015, 18 evictions were ordered by the Courts and completed between March and June 2015, compared to only four (4) between January 1, 2014, and February 28, 2015 (Attachment C).

In addition, as a result of a joint law enforcement effort in November 2014 between the Miami-Dade Police Department, U.S. Marshall Service, Federal Bureau of Investigation (FBI) and Drug Enforcement Agency (DEA) in cooperation with the Department, 31 persons were arrested for weapons, drugs, and gang-related crimes at the Arthur May Villas housing development in South Dade; 18 of those persons arrested were residents of Arthur May Villas.

Consequently, 10 households were served seven 7-day notices, and three (3) households were evicted, with one (1) household moving out on their own. The remaining seven (7) households are pending legal action as they are going through the process.

In an effort to improve current lease enforcement efforts, periodic meetings with staff continue to ensure issues and concerns are discussed along with overall expectations, such as conducting more frequent home visits.

Asset Management Administration also continues to stress the importance of working more closely with the Department's Resident Services Section as well as the Resident Council leadership throughout Public Housing developments to conduct informational meetings with residents. Additionally, staff has begun more frequent walkthroughs of all Public Housing properties to inspect the condition of the grounds, identify issues/concerns and note any violations relative to the exterior of the units.

Continued reinforcement by staff since March has had a positive impact on the department's overall efforts. No additional legislative action is needed at this time to address lease enforcement. PHCD will continue its efforts and modify as needed.


