Subject: Resolution Approving the Plat of Campuzano Subdivision

Recommendation

The following plat is submitted for consideration by the Board of County Commissioners for approval. This plat for Campuzano Subdivision is bounded on the north approximately 150 feet south of SW 134 Street, on the east by SW 104 Court, on the south approximately 325 feet north of SW 136 Street, and on the west by SW 105 Avenue.

The Miami-Dade County Plat Committee recommends approval of this plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Public Works and Waste Management; and Water and Sewer.

Scope

This plat is located in Commission District 8, which is represented by Commissioner Daniella Levine Cava.

Fiscal Impact/Funding Source

If this plat is approved, the fiscal impact to the County would be approximately \$50.00 per year for the maintenance of the new drainage structure once constructed adjacent to the project. These costs would be covered by the Department of Public Works and Waste Management's annual General Fund allocation.

Track Record/Monitor

The Development Services Division of the Department of Regulatory and Economic Resources administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P. L. S.

Campuzano Subdivision (T-23470)


- Located in Section 17, Township 55 South, Range 40 East

- Proposed Usage: Single family residences
- Number of parcels: 2
- This plat meets concurrency

Plat Restrictions

- That the Avenue and Court, as illustrated on the plat, together with all existing and future planting, trees, shrubbery and fire hydrants thereon, are hereby dedicated to the perpetual use of the public for proper purposes, reserving to the dedicators, their successors and assigns the reversion or reversions thereof, whenever discontinued by law.
- That individual wells shall not be permitted within this subdivision, except for swimming pools, sprinkler systems and/or air conditioners.
- That the use of septic tanks will not be permitted on any lot within this subdivision, unless approved for temporary use, in accordance with County and State regulations.
- That all new electric and communication lines, except transmission lines, within this subdivision shall be installed underground.
- That the utility easements, depicted by dashed lines on the plat, are hereby reserved for the installation and maintenance of public utilities.

Developer's Obligation

- Drainage maintenance, which is bonded under bond number 7953 in the amount of \$3,300.00.

RESOLUTION APPROVING THE PLAT OF CAMPUZANO SUBDIVISION, LOCATED IN THE SOUTHWEST 1/4 OF SECTION 17, TOWNSHIP 55 SOUTH, RANGE 40 EAST (BOUNDED ON THE NORTH APPROXIMATELY 150 FEET SOUTH OF SW 134 STREET, ON THE EAST BY SW 104 COURT, ON THE SOUTH APPROXIMATELY 325 FEET NORTH OF SW 136 STREET, AND ON THE WEST BY SW 105 AVENUE)

WHEREAS, Oscar E. Campuzano and Gloria E. Velez, his wife, have this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as Campuzano Subdivision, the same being a subdivision of a portion of land lying and being in the Southwest 1/4 of Section 17, Township 55 South, Range 40 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements.


