A RESOLUTION OF THE MIAMI CITY COMMISSION NOMINATING MS. VANESSA ACOSTA, MS. ARVA MOORE PARKS, MS. JACQUELINE M. ZELMAN, AND MR. KEVIN KIRWIN TO THE MIAMI-DADE COUNTY PUBLIC LIBRARY ADVISORY BOARD IN COMPLIANCE WITH MIAMI-DADE COUNTY CODE SECTION 2-195; FURTHER DIRECTING THE CITY CLERK TO TRANSMIT A COPY OF THIS RESOLUTION TO THE HEREIN DESIGNATED OFFICIALS.

WHEREAS, pursuant to Section 2-195 of the Miami-Dade County Code, the Miami-Dade County Public Library Advisory Board shall consist of eleven (11) members, including three (3) members who are City of Miami ("City") residents; and

WHEREAS, the three (3) City members of the Mlami-Dade County Public Library Advisory Board must be nominated by the City Manager and approved by the City Commission for appointment to the Mlami-Dade County Public Library Advisory Board; and

WHEREAS, the City is committed to ensuring that our libraries remain properly funded, professionally staffed, and adequately stocked with the materials and books the public expects; and

WHEREAS, the City wants its representatives on the Miami-Dade County Library Advisory Board to have input on the Master Plan formulated by Mayor Carlos Gimenez's Blue Ribbon Task Force for the Miami-Dade Public Library System; and

WHEREAS, the City wishes to continue to serve and represent its citizens through the Miami-Dade. County Library Advisory Board; and

WHEREAS, the City Commission nominates four (4) qualified candidates, who are residents of the City: Ms. Vanessa Acosta, Ms. Arva Moore Parks, Ms. Jacqueline M. Zelman and Mr. Kevin Kirwin, three (3) of whom may be appointed to the Miami-Dade County Public Library Advisory Board.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF MIAMI, FLORIDA:

- Section 1. The recitals and findings contained in the Preamble to this Resolution are adopted by reference and incorporated as If fully set forth in this Section.

ARVA MOORE PARKS

Ms. Parks, a Miami native with a master's degree in history, has been researching and writing about South Florida for more than 40 years. She is the author of award-winning documentaries; eight books, including *Miami the Magic City*, the city's official history, and has written or contributed to more than a 20 others. She is an indefatigable historic preservationist and many South Florida landmarks have been preserved because of her leadership.

She has been widely honored for her scholarship, books and advocacy including receiving an honorary doctorate from Barry University and being named an Alumnae of Outstanding Achievement by both the University of Florida and the University of Miami. She is a member of the State of Florida and City of Miami Women's Hall of Fame, held a presidential appointment to the Federal Advisory Council on Historic Preservation and received the Coral Gables Chamber of Commerce first George Merrick Award of Excellence. The Florida Historical Society honored her as the Caroline B. Rossitter "Outstanding Woman in Florida History."

Locally, she is past-chair of the Vizcaya Trust and the City of Miami Planning Advisory Board. She was pro bono acting director and chief curator of the new Coral Gables Museum for 18 months and then served two years as chair of the board. She currently is a member of the board of the University of Miami, the Florida Trust for Historic Preservation and the University of Florida St. Augustine Historic District Board.
