RESOLUTION ESTABLISHING, AS BOARD POLICY, THAT EVERY YEAR, BETWEEN DECEMBER 1-15TH, THE LOBBY OF THE STEPHEN P. CLARK CENTER BE USED BY THE MIAMI-DADE **COUNTY** OFFICE OF COMMUNITY ADVOCACY TO **SHOWCASE** AN ART **EXHIBIT** FEATURING LOCAL ARTISTS TO BE CALLED THE "ART MIAMI-DADE" EXHIBIT

WHEREAS, every year for the past 15 years, [[the]]<sup>1</sup> Miami-Dade County [[Hispanie Affairs Advisory Board ("HAAB")]] has celebrated Hispanic Heritage Month with a Hispanic Art Expressions Exhibit in the lobby of the Stephen P. Clark Center during several weeks in September, October and/or November; and

WHEREAS, one of the purposes of the exhibit is to promote the Hispanic culture through art and sculpture and showcase the diversity of the Hispanic community; and

WHEREAS, in 2015, [[HAAB]] >> Miami-Dade County, through the Office of Community Advocacy, << organized and curated another art exhibit in the lobby of the Stephen P. Clark Center lobby from December 1-15, 2015; and

WHEREAS, the importance of showcasing the art in the Stephen P. Clark Center lobby during the month of December is that it coincides with Art Basel, the annual art show held in Miami Beach which ranks as the premier art show of the Americas and which brings tens of thousands of visitors to its exhibits and to the satellite fairs and events that coincide with Art Basel; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that the foregoing recitals are hereby incorporated herein by reference and adopted by this Board, and that this Board hereby establishes, as a policy of this Board, that every year hereinafter, between December 1-15th, the lobby of the Stephen P. Clark Center shall be used by [[HAAB]] >> the Office of Community Advocacy << to showcase an art exhibit featuring local artists to be called the "Art Miami-Dade" exhibit.
