Subject: Resolution Approving the Waiver of Plat of Habitat for Humanity of Greater Miami, Inc.

Recommendation

The following waiver of plat is submitted for consideration by the Board of County Commissioners for approval. This waiver of plat for Habitat for Humanity of Greater Miami, Inc. is bounded on the north by SW 181 Street, on the east approximately 250 feet west of SW 104 Avenue, on the south approximately 150 feet north of SW 182 Street, and on the west approximately 135 feet east of SW 105 Avenue.

The Miami-Dade County Plat Committee recommends approval and recording of this waiver of plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board;
- Miami-Dade County departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works, and Water and Sewer.

Scope

This waiver of plat is located in Commission District 9, which is represented by Commissioner Dennis C. Moss.

Fiscal Impact/Funding Source

If this waiver of plat is approved the fiscal impact to the County, would be approximately \$50.00 per year for the maintenance of minimal new paving and new drainage, and sidewalk adjacent to the project. These costs would be covered by the Department of Transportation and Public Works' annual General Fund allocation.

Track Record/Monitor

The Development Services Division of the Department of Regulatory and Economic Resources administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P. L. S.



RESOLUTION APPROVING THE WAIVER OF PLAT OF HABITAT FOR HUMANITY OF GREATER MIAMI, INC., D-23697, LOCATED IN THE SOUTHWEST 1/4 OF SECTION 32, TOWNSHIP 55 SOUTH, RANGE 40 EAST (BOUNDED ON THE NORTH BY SW 181 STREET, ON THE EAST APPROXIMATELY 250 FEET WEST OF SW 104 AVENUE, ON THE SOUTH APPROXIMATELY 150 FEET NORTH OF SW 182 STREET, AND ON THE WEST APPROXIMATELY 135 FEET EAST OF SW 105 AVENUE).

WHEREAS, Habitat for Humanity of Greater Miami, Inc., a Florida not-for-profit corporation, has this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a portion of Lot 3, Block 12 of "Plat of West Perrine Subdivision," according to the plat thereof, as recorded in Plat Book 43, at Page 15, of the Public Records of Miami-Dade County, Florida, lying and being in the Southwest 1/4 of Section 32, Township 55 South, Range 40 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said waiver of plat is hereby approved; that the property has been found to be in compliance with Chapter 28, Subdivisions, of the Miami-Dade County Code; that approval of this waiver of plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this Resolution is approved shall be enforced whether or not the various parcels on this waiver of plat conforms to those requirements.


