

RESOLUTION CODESIGNATING THAT PORTION OF SW  
92ND AVENUE BETWEEN SW 40TH STREET (BIRD ROAD)  
AND SW 45TH STREET AS "FLORIDA CHRISTIAN  
PATRIOT AVENUE"

**WHEREAS**, Florida Christian School (FCS) is a private nondenominational Christian school located at 4200 SW 89th Avenue in Miami, Florida; and

**WHEREAS**, FCS provides quality co-ed classes for preschool through high school; and

**WHEREAS**, FCS is accredited by the Southern Association of Colleges and Schools, the Florida Association of Christian Colleges and Schools, and the American Association of Christian Schools; and

**WHEREAS**, from an early age, FCS students are provided with the foundation for an excellent education, as K5 graduates are reading at a level far above national standards, and throughout elementary and middle school FCS students' test scores rank in the top percentiles across the board; and

**WHEREAS**, FCS also offers robust fine arts and athletics programs, and over the past ten years FCS has produced over 100 athletes who have competed at the college level; and

**WHEREAS**, in addition, through its Discovery program FCS provides one-on-one specialized assistance to students with learning difficulties, and FCS is the only school in South Florida accredited by the National Institute for Learning Disabilities; and

**WHEREAS**, the FCS school mascot is the Patriot; and

**WHEREAS**, this Board would like to recognize Florida Christian School and its contributions to the community by codesignating that portion of SW 92nd Avenue between SW 40th Street (Bird Road) and SW 45th Street as “Florida Christian Patriot Avenue”; and

**WHEREAS**, that portion of SW 92nd Avenue between SW 40th Street (Bird Road) and SW 45th Street is a County road located in unincorporated Miami-Dade County; and

**WHEREAS**, this proposed codesignation is located in County Commission District 10,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board:

**Section 1.** Having considered this matter at a public hearing, codesignates that portion of SW 92nd Avenue between SW 40th Street (Bird Road) and SW 45th Street as “Florida Christian Patriot Avenue”.

**Section 2.** Directs the Clerk of the Board to transmit a certified copy of this resolution to the United States Postal Service, the Traffic Signals and Signs Division of the Public Works and Waste Management Department, the Development Services Division of the Regulatory and Economic Resources Department, the Miami-Dade County Police Department, and the Miami-Dade Fire Rescue Department.
