

RESOLUTION APPROVING THE CITY OF SWEETWATER
CODESIGNATION OF THAT PORTION OF NW 5TH STREET
BETWEEN NW 112TH AVENUE AND NW 115TH AVENUE
AS "MANUEL 'MANOLO' FERNANDEZ WAY"

WHEREAS, Manuel "Manolo" Fernandez began his public service with the City of Sweetwater as a bus driver for the Senior Center, and he later served as City Commissioner from 1986 to 2001; and

WHEREAS, Manolo Fernandez always worked tirelessly for the betterment of the entire community, especially for children and seniors during his tenure as City Commissioner; and

WHEREAS, on February 24, 2000, this Board issued a proclamation declaring February 24, 2000 as "Commissioner Manolo Fernandez Day"; and

WHEREAS, on December 7, 2015, the Mayor and City Commission of the City of Sweetwater adopted Resolution No. 15-4133, a copy of which is attached hereto and incorporated by reference, which codesignated NW 5th Street between NW 112th Avenue and NW 115th Avenue as "Manuel 'Manolo' Fernandez Way", in honor of Manolo Fernandez's memory and in recognition of his contributions to the City of Sweetwater; and

WHEREAS, the City of Sweetwater would like the County to install signage indicating this codesignation on County street signs and traffic signal masts arms; and

WHEREAS, NW 5th Street between NW 112th Avenue and NW 115th Avenue is a city street located in the City of Sweetwater; and

WHEREAS, this codesignation is located in County Commission District 12,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the City of Sweetwater codesignation of NW 5th Street between NW 112th Avenue and NW 115th Avenue as “Manuel ‘Manolo’ Fernandez Way”.

Section 2. Directs the Clerk of the Board to send certified copies of this Resolution to the Mayor and City Commission of the City of Sweetwater, the United States Postal Service, the Traffic Signals and Signs Division of the Public Works and Waste Management Department, the Development Services Division of the Regulatory and Economic Resources Department, the Sweetwater Police Department and the Miami-Dade Fire Rescue Department.

The Prime Sponsor of the foregoing resolution is Commissioner Jose "Pepe" Diaz. It was offered by Commissioner _____, who moved its adoption. The motion was seconded by Commissioner _____ and upon being put to a vote, the vote was as follows:

Section 2. The City Commission wishes to memorialize his contribution to the City of Sweetwater and its citizens by naming NW 5th Street between 112th avenue and 115th Avenue in the City of Sweetwater as Manuel "Manolo" Fernandez Way.


Section 3. That a copy of this resolution be forwarded to the Miami-Dade County Public Works Department..
