RESOLUTION NO. R-1006-13

RESOLUTION DIRECTING THE MAYOR OR DESIGNEE TO IDENTIFY ONE OR MORE UNIVERSITIES OR A PROFESSIONAL CONSULTANT TO CONTRACT WITH THE COUNTY TO ANALYZE AND MAKE RECOMMENDATIONS CONCERNING FUTURE INCORPORATIONS AND ANNEXATIONS WITHIN THE UNINCORPORATED AREA

WHEREAS, this Board of County Commissioners (the "Board") has lifted the stay on incorporation of the unincorporated areas of Miami-Dade County; and

WHEREAS, haphazard incorporations and annexations risk certain pockets of low property value areas being left behind and being denied the benefits of annexation or incorporation; and

WHEREAS, this Board would benefit from a report that addresses how the County should proceed to address the unincorporated area; and

WHEREAS, the report to the Board should consider, among other possibilities, full incorporation into various municipalities, annexations into existing municipalities, or incorporation of the remainder of the unincorporated area into a single municipality; and

WHEREAS, an overall plan for incorporations and annexations of the unincorporated area will help to prevent low property value areas in the unincorporated area from being excluded from new municipalities or annexations to existing municipalities; and

WHEREAS, the Annexation and Incorporation Task Force did not develop an overall plan that would prevent low property value areas from being excluded from the creation of new municipalities or annexations to existing municipalities; and

WHEREAS, by partnering with one or more universities or a professional consultant, the County could benefit from an independent study of the issues raised by future annexations and incorporations within the unincorporated area and would be assisted in developing a plan to address the concerns regarding the unincorporated area which will remain after future annexations and incorporations; and

WHEREAS, the Annexation and Incorporation Task Force recommended in its recommendation No. 21 that "...the Board obtain a consultant to make a recommendation on UMSA...[r]ecommending that the annexation and incorporation boundaries be contiguous, logical, and compact while seeking natural boundaries and include an economic component"; and

WHEREAS, the Mayor would best be able to assist the Board in determining the proper approach to contracting with a university or universities or a professional consultant to advise the County on the issues raised by future annexations and incorporations within the unincorporated area,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. The Mayor or designee is directed to identify one or more universities or a professional consultant that has the ability to study proposed annexations and incorporations and develop a plan, in cooperation with appropriate County departments, on how to address the remaining unincorporated areas.

Section 2. Such plan shall include any recommendations to annex specific areas to existing municipalities or that a certain area or areas be included as part of one or more incorporations or a combination of both annexations and incorporations. Such plan shall also

address full annexation or incorporation of the entire unincorporated area, if full incorporation or annexation is determined to be feasible. Any proposed annexations and incorporations should be contiguous, logical, compact, and have natural or built barriers as boundaries, to the extent feasible, and should avoid any proposals which would exclude low property value areas from any proposed new city or annexation area.

Section 3. The study should also include a review of how businesses located in the Unincorporated Municipal Service Area would be affected, provide recommendations on mitigating the impact to these businesses, and address any economic concerns or benefits to be achieved by incorporations and annexations, should there be a decision or decisions by all appropriate parties, including the electorate, which would move toward accomplishing full incorporation/annexation, with the County's role to be in the nature of a regional government.

Section 4. The Mayor or designee is further directed to develop ~~[[a]]~~¹ >>an abbreviated procurement process taking no longer than three weeks<< ~~[[selection process]]~~ which will be utilized by the Mayor in making recommendation to the Board on the selection of one or more universities or a professional consultant, in accordance with this resolution. The Mayor or designee shall suggest an appropriate budget for this study.

Section 5. The Mayor or designee shall provide a report to this Board which includes proposed resolution and contract to engage one or more universities or a professional consultant as contemplated in this resolution within 30 days of the effective date of this resolution.
