Subject: Resolution Approving the Waiver of Plat of Legacy Rentals, LLC

Recommendation

The following waiver of plat is submitted for consideration by the Board of County Commissioners for approval. This waiver of plat for Legacy Rentals, LLC is bounded on the north by NW 56 Street, on the east approximately 400 feet west of NW 27 Avenue, on the south approximately 140 feet north of NW 55 Street, and on the west approximately 200 feet east of NW 29 Avenue.

The Miami-Dade County Plat Committee recommends approval and recording of this waiver of plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Scope

This waiver of plat is located in Commission District 3, which is represented by Commissioner Audrey M. Edmonson.

Fiscal Impact/Funding Source

There is no associated fiscal impact to Miami-Dade County with the approval of this waiver of plat as all improvements are in place.

Track Record/Monitor

The Development Services Division of the Department of Regulatory and Economic Resources administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P. L. S.





RESOLUTION APPROVING THE WAIVER OF PLAT OF LEGACY RENTALS, LLC, D-23737, LOCATED IN THE SOUTHEAST 1/4 OF SECTION 16, TOWNSHIP 53 SOUTH, RANGE 41 EAST (BOUNDED ON THE NORTH BY NW 56 STREET, ON THE EAST APPROXIMATELY 400 FEET WEST OF NW 27 AVENUE, ON THE SOUTH APPROXIMATELY 140 FEET NORTH OF NW 55 STREET, AND ON THE WEST APPROXIMATELY 200 FEET EAST OF NW 29 AVENUE)

WHEREAS, Legacy Rentals, LLC, a Florida limited liability company, has this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a portion of Lot 5 and all of Lots 6 and 7, Block 26, of "Amended Plat of Hialeah Heights", according to the plat thereof, as recorded in Plat Book 28, at Page 24, of the Public Records of Miami-Dade County, Florida, lying and being in the Southeast 1/4 of Section 16, Township 53 South, Range 41 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said waiver of plat is hereby approved; that the property has been found to be in compliance with Chapter 28, Subdivisions, of the Miami-Dade County Code; that approval of this waiver of plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this waiver of plat conforms to those requirements.
