RESOLUTION APPROVING THE CITY OF HIALEAH CODESIGNATION OF THAT PORTION OF EAST 5TH STREET FROM EAST 2ND AVENUE TO EAST 4TH AVENUE AS "PASTOR MEL SANTIESTEBAN SR. WAY"

WHEREAS, after recommendation by the Hialeah Historic Preservation Board, the Mayor and Council of the City of Hialeah passed Resolution No. 2016-22 on February 23, 2016, which codesignated that portion of East 5th Street from East 2nd Avenue to East 4th Avenue as "Pastor Mel Santiesteban Sr. Way", in honor and recognition of Pastor Mel Santiesteban Sr.'s outstanding service and dedication to the City of Hialeah and its residents; and

WHEREAS, a copy of Resolution No. 2016-22 is attached hereto and incorporated by reference; and

WHEREAS, Pastor Santiesteban Sr. was born and raised in Holguin, Cuba and became a resident of the City of Hialeah in 1979; and

WHEREAS, Pastor Santiesteban Sr. became the founder and pastor of the Hialeah Church of Nazarene, where he served for 33 years; and

WHEREAS, in 1996, Pastor Santiesteban Sr. assisted Hialeah residents with clothing, food, and spiritual guidance; and

WHEREAS, in 1996, Pastor Santiesteban Sr. began rescuing homeless and drug addicted people from the streets of Hialeah and providing them shelter; and

WHEREAS, in 1996, Pastor Santiesteban Sr. established a non-profit substance abuse program called the Home of the Nazarene, which has helped rehabilitate many men and women from drug addiction and has assisted these individuals in leading a productive, drug free life; and

WHEREAS, in 1999, Pastor Santiesteban Sr. established another non-profit organization called Hope for the Community, which delivered boxes of food to needy families in Hialeah; and

WHEREAS, Pastor Santiesteban Sr. used his church as shelter during natural disasters and offered food to people during natural disasters; and

WHEREAS, East 5th Street from East 2nd Avenue to East 4th Avenue is a city road located in the City of Hialeah; and

WHEREAS, the City of Hialeah codesignation is located in County Commission District 6; and

WHEREAS, the City of Hialeah would like the County to install signage indicating this codesignation on County street signs and traffic signal mast arms; and

WHEREAS, this Board would also like to honor Pastor Santiesteban Sr. by approving the City of Hialeah codesignation of East 5th Street from East 2nd Avenue to East 4th Avenue as "Pastor Mel Santiesteban Sr. Way",

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the City of Hialeah codesignation of East 5th Street from East 2nd Avenue to East 4th Avenue as "Pastor Mel Santiesteban Sr. Way".

Section 2. Directs the Clerk of the Board to transmit a certified copy of this resolution to the Mayor of the City of Hialeah, the United States Postal Service, the Traffic Signals and Signs Division of the Transportation and Public Works Department, the Development Services Division of the Regulatory and Economic Resources Department, the Hialeah Police Department, and the Hialeah Fire Department.

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY HIALEAH, FLORIDA APPROVING THE CO-DESIGNATION OF THAT PORTION OF EAST 5TH STREET, BETWEEN EAST 2ND AVENUE AND EAST 4TH AVENUE, IN FLORIDA, HIALEAH, **PRESENTLY** UNNAMED, AS "PASTOR **MEL** SANTIESTEBAN SR. WAY", IN HONOR AND MEMORY OF THE OUTSTANDING SERVICE AND DEDICATION OF PASTOR MEL SANTIESTEBAN SR. TO THE CITY OF HIALEAH AND ITS RESIDENTS, WITH THE COST OF SIGNAGE TO BE PAID BY THE CITY.

WHEREAS, born and raised in Holguin, Cuba, Mel Santiesteban Sr. (July 16, 1939 – May 15, 2012) became a resident of the City of Hialeah in 1979;

WHEREAS, in 1979 he became the founder and pastor of the Hialeah Church of Nazarene, or *Iglesia del Nazareno El Buen Pastor*, where he served for thirty-three years;

WHEREAS, in 1980, Pastor Mel Santiesteban Sr. assisted Cubans, who left their native country and found exile in the United States, residing in Hialeah by providing them with clothing, food and spiritual guidance;

WHEREAS, in 1996, Pastor Mel Santiesteban Sr. began rescuing homeless and drug addicts from the streets of Hialeah and placed them at rented houses near Hialeah Church of Nazarene;

WHEREAS, in 1996, Pastor Mel Santiesteban Sr. established a non-profit substance abuse program called the "Home of the Nazarene", which as of today has rescued many men and women from drug addiction, who are now, thanks to Pastor Mel Santiesteban Sr., rehabilitated and living a productive, drug free life;

WHEREAS, in 1999, Pastor Mel Santiesteban Sr. established a non-profit community development corporation called "Hope for the Community" to help needy families in Hialeah by delivering boxes of food;

WHEREAS, Pastor Mel Santiesteban Sr. always opened the doors of the Hialeah Church of Nazarene to the community during hurricanes and other natural disasters, offering food and shelter for everyone during times of need;

WHEREAS, Pastor Mel Santiesteban Sr lead, together with his congregation and the community, several world relief efforts to collect clothing, food, and medications during international crisis;

WHEREAS, the co-designation of that portion of East 5th Street, between East 2nd Avenue and East 4th Avenue, in Hialeah, Florida, presently unnamed, as "PASTOR MEL SANTIESTEBAN SR. WAY", presently unnamed, is in honor and memory of the outstanding service and dedication of Pastor Mel Santiesteban Sr. Way;

WHEREAS, the Historic Preservation Board recommended approval of this Resolution on January 11, 2016.

THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: The portion of East 5th Street, between East 2nd Avenue and East 4th Avenue, in Hialeah, Florida, presently unnamed, is hereby co-designated as "PASTOR MEL SANTIESTEBAN SR. WAY", and shall be known as such from this day forward, with the costs of signage to be paid by the City.
