Subject: Resolution Approving the Plat of TCG at Flagler

Recommendation

The following plat is submitted for consideration by the Board of County Commissioners for approval. This plat for TCG at Flagler is bounded on the north approximately 100 feet south of theoretical NW 3 Street, on the east by NW 71 Avenue, on the south approximately 450 feet north of NW 1 Terrace, and on the west approximately 375 feet east of NW 72 Avenue.

The Miami-Dade County Plat Committee recommends approval and recording of this plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resource; Transportation and Public Works; and Water and Sewer.

Scope

This plat is located in Commission District 6, which is represented by Commissioner Rebeca Sosa.

Fiscal Impact/Funding Source

If this plat is approved, the fiscal impact to the County would be approximately \$50.00 per year for the maintenance of the recently constructed road adjacent to the project. These costs would be covered by the Department of Transportation and Public Works' annual General Fund allocation.

Track Record/Monitor

The Development Services Division of the Department of Regulatory and Economic Resources administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P. L. S.

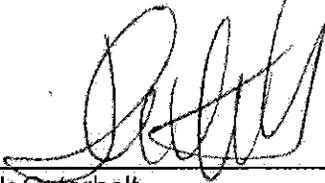
- Located in Section 2, Township 54 South, Range 40 East
- Zoning: RU-4M
- Proposed Usage: Apartment building with 29 units
- Number of parcels: 1
- This plat meets concurrency.

Plat Restrictions

- That the Avenue, as illustrated on the plat, together with all existing and future plantings, trees, shrubbery and fire hydrants thereon, are hereby dedicated to the perpetual use of the public for proper purposes, reserving to the dedicators, their successors and assigns the reversion or reversions thereof, whenever discontinued by law.
- That individual wells shall not be permitted within this subdivision, except for swimming pools, sprinkler systems and/or air conditioners.
- That the use of septic tanks will not be permitted within this subdivision, unless approved for temporary use, in accordance with County and State regulations.
- That all new electric and communication lines, except transmission lines, within this subdivision, shall be installed underground.

Developer's Obligation

- Drainage maintenance and monumentation, which are bonded under bond number 7968 in the amount of \$3,960.00.

RESOLUTION APPROVING THE PLAT OF TCG AT FLAGLER, LOCATED IN THE NORTHEAST 1/4 OF SECTION 2, TOWNSHIP 54 SOUTH, RANGE 40 EAST (BOUNDED ON THE NORTH APPROXIMATELY 100 FEET SOUTH OF THEORETICAL NW 3 STREET, ON THE EAST BY NW 71 AVENUE, ON THE SOUTH APPROXIMATELY 450 FEET NORTH OF NW 1 TERRACE, AND ON THE WEST APPROXIMATELY 375 FEET EAST OF NW 72 AVENUE)

WHEREAS, TCG Flagler, LLC, a Florida limited liability company, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as TCG at Flagler, the same being a subdivision of a portion of land lying and being in the Northeast 1/4 of Section 2, Township 54 South, Range 40 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this Resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements.
