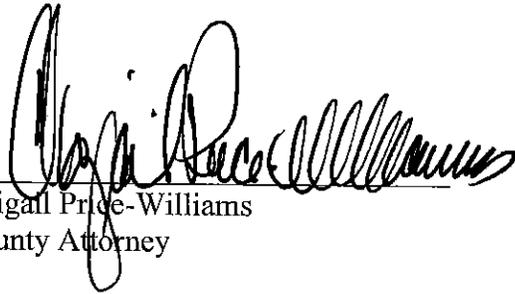

RESOLUTION NO. _____

RESOLUTION DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO SEEK FUNDS TO ESTABLISH AND MAINTAIN A RESERVE FUND TO FACILITATE IMPLEMENTATION OF THE RECOMMENDATIONS OF THE MIAMI-DADE COUNTY SEA LEVEL RISE TASK FORCE, AND TO PREPARE A REPORT FOR THIS BOARD

WHEREAS, in 2013, pursuant to Resolution No. R-599-13, this Board created the Miami-Dade County Sea Level Rise Task Force; and

WHEREAS, this Board subsequently adopted multiple resolutions in order to implement the recommendations of the Sea Level Rise Task Force; and

WHEREAS, it may be advantageous to have a reserve fund that is dedicated to funding the implementation of the recommendations of the Sea Level Rise Task Force, particularly the adaptation and resiliency strategies contained therein; and

WHEREAS, having such a reserve fund available may be an important tool for Miami-Dade County to enhance its ability to respond to sea level rise issues, and such a reserve fund may allow the County to take necessary steps or make needed improvements more quickly than would otherwise be possible; and

WHEREAS, in order to initiate and establish such a reserve fund, Miami-Dade County could seek funding from federal, state, and local sources, including, but not limited to, grants from governmental agencies and non-profit organizations; and

WHEREAS, having such a reserve fund available to carry out the recommendations of the Sea Level Rise Task Force, particularly the adaptation and resiliency strategies contained therein, could continue to enhance Miami-Dade County's ability and readiness to address sea level rise issues and concerns well into the future,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board hereby directs the County Mayor or County Mayor's designee to seek funding to establish and maintain a reserve fund that will be dedicated to carrying out the recommendations of the Sea Level Rise Task Force, and particularly the adaptation and resiliency strategies contained therein. Such funding may be sought from a variety of sources, including, but not limited to, federal, state, and local sources, such as grants from governmental entities and non-profit organizations. The County Mayor or County Mayor's designee shall prepare a report regarding same, and shall provide this report to the Board within 180 days of the effective date of this resolution, and shall place the completed report on an agenda of the Board pursuant to Ordinance No. 14-65.

The Prime Sponsor of the foregoing resolution is Commissioner Rebeca Sosa, and the Co-Sponsors are Commissioner Daniella Levine Cava and Commissioner Sally A. Heyman. It was offered by Commissioner _____, who moved its adoption. The motion was seconded by Commissioner _____ and upon being put to a vote, the vote was as follows:
