

RESOLUTION APPROVING THE CITY OF SWEETWATER
CODESIGNATION OF THAT PORTION OF SW 5TH STREET
BETWEEN SW 112TH AVENUE AND SW 115TH AVENUE
AS “MANUEL ‘MANOLO’ FERNANDEZ WAY”;
RESCINDING RESOLUTION NO. R-221-16

WHEREAS, on December 7, 2015, the Mayor and City Commission of the City of Sweetwater adopted Resolution No. 15-4133, which codesignated SW 5th Street between SW 112th Avenue and SW 115th Avenue as “Manuel ‘Manolo’ Fernandez Way”, in honor of Manolo Fernandez’s memory and in recognition of his contributions to the City of Sweetwater; and

WHEREAS, the copy of Resolution No. 15-4133 that was forwarded to the County for approval, however, contained an incorrect front page which erroneously noted the “Manuel ‘Manolo’ Fernandez Way” as being NW 5th Street between NW 112th Avenue and NW 115th Avenue; and

WHEREAS, as a result, on March 8, 2016, this Board adopted Resolution No. R-221-16, which approved the City of Sweetwater codesignation of NW 5th Street between NW 112th Avenue and NW 115th Avenue as “Manuel ‘Manolo’ Fernandez Way”; and

WHEREAS, the Sweetwater City Clerk’s Office has recently forwarded to the County the correct version of Resolution No. 15-4133 that was adopted by the Sweetwater Mayor and City Commission on December 7, 2015, a copy of which is attached hereto and incorporated by reference; and

WHEREAS, accordingly, this Board would now like to approve the City of Sweetwater codesignation of SW 5th Street between SW 112th Avenue and SW 115th Avenue as “Manuel ‘Manolo’ Fernandez Way” and rescind Resolution No. R-221-16; and

WHEREAS, the City of Sweetwater would like the County to install signage indicating this codesignation on County street signs and traffic signal masts arms; and

WHEREAS, SW 5th Street between SW 112th Avenue and SW 115th Avenue is a city street located in the City of Sweetwater; and

WHEREAS, this codesignation is located in County Commission District 12,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the City of Sweetwater codesignation of SW 5th Street between SW 112th Avenue and SW 115th Avenue as “Manuel ‘Manolo’ Fernandez Way”.

Section 2. Rescinds Resolution No. R-221-16.

Section 3. Directs the Clerk of the Board to send certified copies of this Resolution to the Mayor and City Commission of the City of Sweetwater, the United States Postal Service, the Traffic Signals and Signs Division of the Transportation and Public Works Department, the Development Services Division of the Regulatory and Economic Resources Department, the Sweetwater Police Department and the Miami-Dade Fire Rescue Department.

The Prime Sponsor of the foregoing resolution is Commissioner Jose "Pepe" Diaz. It was offered by Commissioner _____, who moved its adoption. The motion was seconded by Commissioner _____ and upon being put to a vote, the vote was as follows:

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF SWEETWATER, FLORIDA, HONORING THE MEMORY OF MANUEL "MANOLO" FERNANDEZ BY DESIGNATING SW 5TH STREET BETWEEN 112TH AVENUE AND 115TH AVENUE IN THE CITY OF SWEETWATER TO ALSO BE KNOWN AS MANUEL "MANOLO" FERNANDEZ WAY; AND PROVIDING AN EFFECTIVE DATE




Section 3. That a copy of this resolution be forwarded to the Miami-Dade County Public Works Department.
