

RESOLUTION WAIVING, BY A TWO-THIRDS VOTE OF THE FULL MEMBERSHIP OF THE BOARD, THE TERM LIMITS IMPOSED ON MAX BLUMBERG PURSUANT TO SECTION 2-1113(D) OF THE CODE OF MIAMI-DADE COUNTY, FLORIDA; WAIVING, BY A TWO-THIRDS VOTE OF THE BOARD MEMBERS PRESENT, THE TERM LIMITS IMPOSED ON MAX BLUMBERG PURSUANT TO SECTION 2-11.38.2 OF THE CODE OF MIAMI-DADE COUNTY, FLORIDA; AND REAPPOINTING HIM TO THE VIZCAYA MUSEUM AND GARDENS TRUST BOARD FOR ANOTHER TERM

WHEREAS, Section 2-1113(D) of the Code of Miami-Dade County, Florida (“Code”) provides that no member of the Vizcaya Museum and Gardens Trust board (“Vizcaya Trust”) “shall be permitted to serve more than two (2) consecutive and complete terms of three (3) years each unless so authorized by a two-thirds (2/3) vote of the full membership of the Board of County Commissioners”; and

WHEREAS, in addition, Section 2-11.38.2 of the Code provides that no board member shall serve more than eight consecutive years on any one County board unless the Board of County Commissioners (the “Board”), by a two-thirds vote of the members present, votes to waive the term limit; and

WHEREAS, Max Blumberg has reached his term limit on the Vizcaya Trust; and

WHEREAS, this Board wishes to waive the applicable term limits in Sections 2-1113(D) and 2-11.38.2 of the Code, and reappoint Max Blumberg to the Vizcaya Trust for another term; and

WHEREAS, Max Blumberg has served on the Vizcaya Trust since 2001 with distinction, also served for many years as a member and President of The Vizcayans, Inc., has personally provided financial support to Vizcaya, and has been active on numerous Vizcaya Trust Committees, including the Collections Management Committee; and

WHEREAS, this Board, pursuant to Section 2-1113(D) of the Code, by a two-thirds vote of its full membership, and pursuant to Section 2-11.38.2 of the Code, by a two-thirds vote of Board members present, desires to waive the applicable term limits and re-appoint Max Blumberg to an additional three year term as a member of the Vizcaya Trust,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board, by a two-thirds vote of the full membership of the Board, waives the term limit restrictions in Section 2-1113(D) of the Code for Max Blumberg, and, by a two-thirds vote of Board members present, waives the term limit restrictions in Section 2-11.38.2 of the Code for Max Blumberg, and reappoints him to another three year term as a member of the board of the Vizcaya Trust.

The Prime Sponsor of the foregoing resolution is Commissioner Jose "Pepe" Diaz. It was offered by Commissioner _____, who moved its adoption. The motion was seconded by Commissioner _____ and upon being put to a vote, the vote was as follows:
