## **Recommendation**

The following waiver of plat is submitted for consideration by the Board of County Commissioners for approval. This waiver of plat for 7255 Holdings, LLC is bounded on the north approximately 430 feet south of SW 72 Street, on the east approximately 140 feet west of SW 53 Place, on the south approximately 150 feet north of SW 74 Street, and on the west by SW 54 Avenue.

The Miami-Dade County Plat Committee recommends approval and recording of this waiver of plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

## **Scope**

This waiver of plat is in Commission District 7, which is represented by Commissioner Xavier L. Suarez.

## **Fiscal Impact/Funding Source**

There is no fiscal impact to Miami-Dade County with the approval of this waiver of plat as all improvements are in place.

RESOLUTION APPROVING THE WAIVER OF PLAT OF 7255 HOLDINGS, LLC, D-23700, LOCATED IN THE NORTHWEST 1/4 OF SECTION 31, TOWNSHIP 54 SOUTH, RANGE 41 EAST (BOUNDED ON THE NORTH APPROXIMATELY 430 FEET SOUTH OF SW 72 STREET, ON THE EAST APPROXIMATELY 140 FEET WEST OF SW 53 PLACE, ON THE SOUTH APPROXIMATELY 150 FEET NORTH OF SW 74 STREET, AND ON THE WEST BY SW 54 AVENUE)

**WHEREAS**, 7255 Holdings, LLC, a Florida limited liability company, has this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a portion of Tract 5 of “Revised Plat of 2nd Amended Plat of High Pines”, according to the plat thereof, as recorded in Plat Book 31, at Page 57, of the Public Records of Miami-Dade County, Florida, lying and being in the Northwest 1/4 of Section 31, Township 54 South, Range 41 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,
