Subject: Resolution Approving the Plat of Palmera Estates South

## **Recommendation**

The following plat is submitted for consideration by the Board of County Commissioners for approval. This plat for Palmera Estates South is bounded on the north by SW 32 Street, on the east by SW 145 Avenue, on the south by SW 32 Terrace, and on the west by SW 147 Avenue.

The Miami-Dade County Plat Committee recommends approval and recording of this plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

## **Scope**

This plat is located in Commission District 11, which is represented by Commissioner Juan C. Zapata.

## **Fiscal Impact/Funding Source**

If this plat is approved, the fiscal impact to the County would be approximately \$350.00 per year for the maintenance of those portions of recently-constructed roads adjacent to the project. These costs would be covered by the Department of Transportation and Public Works' annual General Fund allocation.

## **Track Record/Monitor**

The Development Services Division of the Department of Regulatory and Economic Resources administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P. L. S.

## **Background**

Palmera Estates South (T-23391)


- Located in Section 15, Township 54 South, Range 39 East
- Zoning: RU-1M(a)
- Proposed Usage: Single family residences
- Number of parcels: 11
- This plat meets concurrency.

**Plat Restrictions**

- That the Avenues, Terrace, and Street, as illustrated on the plat, together with all existing and future plantings, trees, shrubbery and fire hydrants thereon, are hereby dedicated to the perpetual use of the public for proper purposes, reserving to the dedicators, their successors and assigns the reversion or reversions thereof, whenever discontinued by law.
- That individual wells shall not be permitted within this subdivision, except for swimming pools, sprinkler systems and/or air conditioners.
- That the use of septic tanks will not be permitted on any lot within this subdivision, unless approved for temporary use, in accordance with County and State regulations.
- That all new electric and communication lines, except transmission lines, within this subdivision, shall be installed underground.
- That the 10 foot wide utility easement, depicted by dashed lines on the plat, are hereby reserved for the installation and maintenance of public utilities.

**Developer's Obligation**

- Paving maintenance, drainage maintenance, sidewalks, detectable warning surfaces, and monumentation are bonded under bond number 7972 in the amount of \$50,491.00.

RESOLUTION APPROVING THE PLAT OF PALMERA ESTATES SOUTH, LOCATED IN THE NORTHWEST 1/4 OF SECTION 15, TOWNSHIP 54 SOUTH, RANGE 39 EAST (BOUNDED ON THE NORTH BY SW 32 STREET, ON THE EAST BY SW 145 AVENUE, ON THE SOUTH BY SW 32 TERRACE, AND ON THE WEST BY SW 147 AVENUE)

**WHEREAS**, Wechsler Development Group, LLC, a Florida limited liability company, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as Palmera Estates South, the same being a replat of a portion of Tract 7 of "J. G. Head's Farms", according to the plat thereof, as recorded in Plat Book 46, at Page 44, of the Public Records of Miami-Dade County, Florida, lying and being in the Northwest 1/4 of Section 15, Township 54 South, Range 39 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements.
