Subject: Resolution Approving the Plat of Aloft Airport Hotel

Recommendation

The following plat is submitted for consideration by the Board of County Commissioners for approval. This plat for Aloft Airport Hotel is bounded on the north by NW 36 Street, on the east by NW 72 Avenue, on the south by the Dressels Dairy Canal, and on the west approximately 600 feet east of NW 74 Avenue.

The Miami-Dade County Plat Committee recommends approval and recording of this plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami Dade County School Board; and
- Miami-Dade County departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resource; Transportation and Public Works; and Water and Sewer.

Scope

This plat is located in Commission District 12, which is represented by Commissioner Jose "Pepe" Diaz.

Fiscal Impact/Funding Source

There is no fiscal impact to Miami-Dade County with the approval of this plat as all improvements are in place.

Track Record/Monitor

The Development Services Division of the Department of Regulatory and Economic Resources administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P. L. S.

Background

Aloft Airport Hotel (T-23562)


- Located in Section 26, Township 53 South, Range 40 East
- Zoning: BU-3
- Proposed Usage: Existing office building and proposed 125 – room hotel
- Number of parcels: one (1)
- This plat meets concurrency

Plat Restrictions

- That the Street and Avenue, as illustrated on the plat, together with all existing and future planting, trees, shrubbery and fire hydrants thereon, are hereby dedicated to the perpetual use of the public for proper purposes, reserving to the dedicators, their successors and assigns the reversion or reversions thereof, whenever discontinued by law.
- That individual wells shall not be permitted within this subdivision, except for swimming pools, sprinkler systems and/or air conditioners.
- That the use of septic tanks will not be permitted within this subdivision, unless approved for temporary use, in accordance with County and State regulations.
- That all new electric and communication lines, except transmission lines, within this subdivision, shall be installed underground.
- That the utility easements, depicted by dashed lines on the plat, are hereby reserved for the installation and maintenance of public utilities.
- That a two (2) foot easement adjacent to all Public Rights-of-Way in this subdivision is hereby reserved for fire hydrants, guardrails and street lights.

Developer's Obligation

- None as all improvements are in place.

RESOLUTION APPROVING THE PLAT OF ALOFT AIRPORT HOTEL, LOCATED IN THE NORTHWEST 1/4 OF SECTION 26, TOWNSHIP 53 SOUTH, RANGE 40 EAST (BOUNDED ON THE NORTH BY NW 36 STREET, ON THE EAST BY NW 72 AVENUE, ON THE SOUTH BY THE DRESSELS DAIRY CANAL, AND ON THE WEST APPROXIMATELY 600 FEET EAST OF NW 74 AVENUE).

WHEREAS, 7220 NW 36th Street Investments, LLC, a Florida limited liability company, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as ALOFT AIRPORT HOTEL, the same being a replat of Tract "B", of "Plaza Executive Centre-First Addition", according to the plat thereof, as recorded in Plat Book 100, at Page 58 of the Public Records of Miami-Dade County, Florida, lying and being in the Northwest 1/4 of Section 26, Township 53 South, Range 40 East, Miami-Dade County, Florida, and it appears that all requirements of the law concerning said plat insofar as the authority of the Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this Resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements.


