Subject: Resolution Approving the Waiver of Plat for Corner Investment Group LLC

Recommendation

The following waiver of plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This waiver of plat for Corner Investment Group LLC is bounded on the north by SW 290 Street, southeasterly by Old Dixie Highway, and southwesterly approximately 160 feet northeasterly of SW 160 Avenue.

The Miami-Dade County Plat Committee recommends approval and recording of this waiver of plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources.

Scope

This waiver of plat is located in Commission District 8, which is represented by Commissioner Daniella Levine Cava.

Fiscal Impact/Funding Source

If this waiver of plat is approved, the fiscal impact to the County would be approximately \$50.00 per year for the maintenance of new sidewalks once constructed adjacent to the project. These costs would be covered by the Department of Transportation and Public Works' annual General Fund allocation.

Track Record/Monitor

The Development Services Division of the Department of Regulatory and Economic Resources administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P. L. S.



RESOLUTION APPROVING THE WAIVER OF PLAT OF CORNER INVESTMENT GROUP LLC, D-23776, LOCATED IN THE SOUTHEAST 1/4 OF SECTION 05, TOWNSHIP 57 SOUTH, RANGE 39 EAST (BOUNDED ON THE NORTH BY SW 290 STREET, SOUTHEASTERLY BY OLD DIXIE HIGHWAY, AND SOUTHWESTERLY APPROXIMATELY 160 FEET NORTHEASTERLY OF SW 160 AVENUE)

WHEREAS, Corner Investment Group LLC, a Florida limited liability company, has this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a portion of Tract 10, of “Second Revised Plat Portion of Section No. 1 Biscayne Entrada”, as recorded in Plat Book 45, at Page 12, of the Public Records of Miami-Dade County, Florida, and Lots A, B, C, and P, of “Modello Station Lots”, as recorded in Plat Book 7, at Page 63, of the Public Records of Miami-Dade County, Florida, lying and being in the Southeast 1/4 of Section 05, Township 57 South, Range 39 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said waiver of plat is hereby approved; that the property has been found to be in compliance with Chapter 28, Subdivisions, of the Miami-Dade County Code; that approval of this waiver of plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this waiver of plat conforms to those requirements.


