Subject: Resolution Approving the Waiver of Plat for Albert Rodriguez and Lex Llanes

Recommendation

The following waiver of plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This waiver of plat for Albert Rodriguez and Lex Llanes is bounded on the north approximately 240 feet south of SW 92 Street, on the east approximately 360 feet west of SW 94 Place, on the south by SW 93 Street, and on the west approximately 270 feet east of SW 97 Avenue.

The Miami-Dade County Plat Committee recommends approval and recording of this waiver of plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources.

Scope

This waiver of plat is located in Commission District 7, which is represented by Commissioner Xavier L. Suarez.

Fiscal Impact/Funding Source

There is no fiscal impact to Miami-Dade County with the approval of this waiver of plat as all improvements are in place.

RESOLUTION APPROVING THE WAIVER OF PLAT OF ALBERT RODRIGUEZ AND LEX LLANES, D-23790, LOCATED IN THE NORTHWEST 1/4 OF SECTION 04, TOWNSHIP 55 SOUTH, RANGE 40 EAST (BOUNDED ON THE NORTH APPROXIMATELY 240 FEET SOUTH OF SW 92 STREET, ON THE EAST APPROXIMATELY 360 FEET WEST OF SW 94 PLACE, ON THE SOUTH BY SW 93 STREET, AND ON THE WEST APPROXIMATELY 270 FEET EAST OF SW 97 AVENUE)

WHEREAS, Albert Rodriguez and Lex Llanes, have this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a portion of land lying and being in the Northwest 1/4 of Section 04, Township 55 South, Range 40 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,


