Subject: Resolution Approving the Plat of Miami Country Day School

Recommendation

The following plat is hereby submitted for consideration by the Board of County Commissioners for approval. This plat for Miami Country Day School is bounded on the north approximately 250 feet south of NE 111 Street, on the east by Biscayne Canal (Canal C-8), on the south by NE 107 Street, and on the west by NE 6 Avenue.

The Miami-Dade County Plat Committee recommends approval of this of plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources.

Scope

This plat is located in Commission District 3, which is represented by Commissioner Audrey M. Edmonson.

Fiscal Impact/Funding Source

There is no fiscal impact to Miami-Dade County with the approval of this plat as all improvements are in place.

Track Record/Monitor

The Development Services Division of the Department of Regulatory and Economic Resources administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P.L.S.

Background

Miami Country Day School (T-23554)

- Located in Section 31, Township 52 South, Range 42 East
- Zoning: RU-1, BU-1, and BU-1A
- Proposed Usage: Existing school with proposed expansion
- Number of Tracts: 2 (two)
- This plat meets concurrency.

Plat Restrictions

- That Avenue and Street, as illustrated on the plat, together with all existing and future plantings, trees, shrubbery and fire hydrants thereon, are hereby dedicated to the perpetual use of the public for proper purposes, reserving to the dedicators, their successors or assigns the reversion or reversions thereof, whenever discontinued by law.
- That individual wells shall not be permitted within this subdivision except for swimming pools, sprinkler systems and/or air conditioners.
- That the use of septic tanks will not be permitted on any tract within this subdivision unless approved for temporary use in accordance with County and State regulations.
- That all new electric and communication lines, except transmission lines, within this subdivision shall be installed underground.
- That the utility easements, depicted by dashed lines on the plat, are reserved for the installation and maintenance of public utilities.

Developer's Obligation

None as all improvements are in place.

RESOLUTION APPROVING THE PLAT OF MIAMI COUNTRY DAY SCHOOL, LOCATED IN THE SOUTHEAST 1/4 OF SECTION 31, TOWNSHIP 52 SOUTH, RANGE 42 EAST (BOUNDED ON THE NORTH APPROXIMATELY 250 FEET SOUTH OF NE 111 STREET, ON THE EAST BY BISCAYNE CANAL (CANAL C-8), ON THE SOUTH BY NE 107 STREET AND ON THE WEST BY NE 6 AVENUE)

WHEREAS, Miami Country Day School, Inc., a Florida not for profit corporation, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as Miami Country Day School, the same being a replat of Tract 1, "Revised Plat of Biscayne Tropical Gardens," according to the plat thereof, as recorded in Plat Book 34, at Page 59; Tract 2, "Revised Plat Cochran Manor," according to the plat thereof as, recorded in Plat Book 35, at Page 48; and Lot 3, and portions of Lots 4 and 5, Block 14, "Julia D. Tuttle's Subdivision," according to the plat thereof, as recorded in Plat Book "B," at Page 4, all of the Public Records of Miami, Dade County, Florida, lying and being in the Southeast 1/4 of Section 31, Township 52 South, Range 42 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements.


