BACKGROUND

The Miami-Dade County Hispanic Affairs Advisory Board was created by Ordinance No. 92-41 on May 19, 1992. The Board was created to serve in an advisory capacity to the Board of County Commissioners, County Administration, the community, and all agencies and residents of Miami-Dade County, with respect to matters pertaining to the Hispanic community in the County. The Board is tasked with initiating and recommending plans and programs for coordination of the activities of governmental entities and non-governmental entities pertaining to the Hispanic community. Moreover, the purpose of the Board is to function as a medium for said entities to utilize and consult with in formulating solutions aimed at the diverse issues surrounding the Hispanic community in the County in addition to devising plans for the future of this ever growing community.

Since the creation of the Hispanic Affairs Advisory Board, the Hispanic population in Miami-Dade County has increased by over 15% bringing it to a total 65.2% of the entire County's population. The continuation of this Board will ensure that the Miami-Dade County successfully identifies and monitors issues within the ever developing Hispanic community.

ORDINANCE NO. 92 - 41

ORDINANCE CREATING THE DADE COUNTY
HISPANIC AFFAIRS ADVISORY BOARD;
PROVIDING BOARD'S PURPOSE AND FUNCTION;
PROVIDING FOR MEMBERSHIP REQUIREMENTS
AND TERMS; PROVIDING FOR STAFF SUPPORT;
PROVIDING SEVERABILITY, INCLUSION IN THE
CODE AND EFFECTIVE DATE

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF DADE COUNTY, FLORIDA:

Section 1. There is hereby created the Dade County Hispanic Affairs Advisory Board.

Section 2. The Dade County Hispanic Affairs Advisory

Board shall be composed of twenty-seven (27) members who shall be
permanent residents and electors of the county and who shall have
a knowledge of and interest in the county's Hispanic community.

Each county commissioner shall appoint three members of the

Board: one member for an initial one-year term, one member for an
initial two-year term, and one member for an initial three-year
term. Appointments after the initial term shall be for a term
of three years.

Section 3. The members of the Board shall elect a chairperson and vice chairperson, who shall serve at the will of the Board. Eighteen (18) members of the Board shall constitute a quorum necessary to hold a meeting and take any action. A majority vote of the quorum of the Board shall be necessary to take any action. Members shall serve without compensation. The chairperson or vice chairperson may call meetings of the

board. Meetings may also be called by written notice signed by eighteen (13) members. The Board at any duly noticed meeting may fix and call a meeting on a future date. All meetings shall be public.

Section 4. The Board shall have the following duties, powers and responsibilities:

- (a) To serve in an advisory capacity to the county commission, the county administration, the community, and all agencies and persons in Dade County, Florida, in respect to matters pertaining to the Hispanic community of Dade County.
- (b) To formulate and recommend plans and programs for coordination of the activities of governmental entities and nongovernmental agencies pertaining to the Hispanic community.
- (c) It is the express purpose of this Board to serve as a medium for responsible persons to utilize and consult with in attempting to understand and solve the many complex problems involved with the Hispanic community in Dade county and to make findings and recommendations to the county commission and the county administration regarding such matters.
- (d) The Board shall annually report to the commission as to its findings and recommendations.
- (e) To perform such other duties as may from time to time be assigned to it by resolution of the county commission.

Section 5. The County Manager, County Attorney and Clark of the Board shall provide appropriate support for the Hispanic Affairs Advisory Board.

Section 6. If any section, subsection, sentence, clause or provision of this ordinance is held invalid, the remainder of this ordinance shall not be affected by such invalidity.

Section 7. It is the intention of the Board of County Commissioners, and it is hereby ordained that the provisions of this ordinance shall become and be made a part of the Code of Metropolitan Dade County, Florida. The sections of this ordinance may be renumbered or relettered to accomplish such intention, and the word "ordinance" may be changed to "section," or "article," or other appropriate word.

Section 8. This ordinance shall become effective ten (10) days after the data of enactment.

A substitute was presented and forwarded to the BCC with a favorable recommendation at the 10-15-14 Health and Social Services Committee. This substitute differs from the original in that it:

- (1) Provides that the nominating committee, proposed to be created for the purpose of nominating 13 of the 26 members of the Hispanic Affairs Advisory Board, will be selected by the Hispanic Affairs Advisory Board from its membership instead of by the Office of Community Advocacy; provides that the Hispanic Affairs Advisory Board shall make such appointments, following required criminal background checks and research; provides that the Hispanic Affairs Advisory Board shall develop nominating committee procedures; and eliminates the requirement that the thirteen members nominated by the nominating committee reside in each of the thirteen commission districts.
- (2) Provides that after one year of not holding an elected office on the Hispanic Affairs Advisory Board, a member may be elected to the same office he or she previously held for two consecutive years.
- (3) Does not require the Clerk of the Board to record the minutes of board meetings but still requires the Clerk to maintain minutes of the board's meetings.

ORDINANCE AMENDING SECTIONS 2-532, 2-533, 2-534, AND 2-535 OF THE CODE OF MIAMI-DADE COUNTY, FLORIDA, PERTAINING TO THE MIAMI-DADE COUNTY HISPANIC AFFAIRS ADVISORY BOARD'S COMPOSITION, TERMS OF OFFICE, DUTIES, AND SUPPORT; PROVIDING SEVERABILITY, INCLUSION IN THE CODE, AND AN

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA:

Section 1. Section 2-532 of the Code of Miami-Dade County, Florida, is hereby amended to read as follows:¹

Sec. 2-532. Composition; terms.

EFFECTIVE DATE

The Miami-Dade County Hispanic Affairs Advisory Board >> ("the board"), in accordance with the provisions of Section 2-11.38 of the Code of Miami-Dade County as may be amended.<< shall be composed of [[twenty-seven-(27)]] >> twenty-six (26) << members who shall be permanent residents and electors of the county and who shall have a knowledge of and interest in the county's Hispanic community. Each county commissioner shall appoint [[three (3) members of the Board: one member for an initial one year term, one member for an initial two-year term, and one member for an initial three-year term. Appointments after the initial term shall be for a term of three (3) years.]] >> one member to the board, and << [[one member residing in each of the thirteen (13) commission districts]]² >> the other thirteen (13) members << >> by a nominating

Words stricken through and/or [[double bracketed]] shall be deleted. Words underscored and/or >>double arrowed<< constitute the amendment proposed. Remaining provisions are now in effect and remain unchanged.

The board shall develop procedures for the creation of the nominating committee in its bylaws. The nominating committee shall recommend potential members for appointment by the Hispanic Affairs Advisory Board, subject to compliance with the requirements of Section 2-11.38,1(b) of the Code of Miami-Dade County, as may be amended, including the requirement relating to criminal history background checks on potential advisory board members performed by the Office of the Inspector General and compliance with the requirements of Resolution No. R-636-14, as may be amended, pertaining to background research on potential advisory board members performed by the Office of the Commission Auditor. The board shall work with the Office of Community Advocacy or successor department to << >> advertise vacancies occurring on the Hispanic Affairs Advisory Board in publications of general circulation and maintain an online application to generate a pool of potential members for the nominating committee's consideration, << [[The nominating committee shall recommend potential members for approval of the Board of County Commissioners in accordance with Section 2 11.38.1(b) of the Code of Minmi Dade County as may be amended. 11

>>All appointments shall be made for a term of four (4) years. No member may serve more than eight (8) consecutive years in accordance with Section 2-11.38.2 of the Code of Miami-Dade County as may be amended. This section shall apply to all board members, except that current board members shall be allowed to complete their current terms.

Notwithstanding any other provision of the Code of Miami-Dade County, a board member shall be automatically removed if, in a given County fiscal year: the member is absent from two (2) consecutive meetings without an acceptable excuse or the member is absent from three (3) of the board's meetings without an acceptable excuse. An 'acceptable excuse' is defined as an absence for medical reasons, business reasons, personal reasons, or any other reason which the board, by a two-thirds (2/3) vote of its membership, deems appropriate. If a member is absent with an acceptable excuse from three (3) or more meetings, the board may vote to remove the member from the board.

A member shall be considered absent from a meeting if the member is not physically present for at least seventy-five (75) percent of the meeting's duration. A member shall also be considered absent from a meeting if the member refrains from voting on any matter for which voting is conducted at the meeting, unless the member is prevented from voting by a conflict of interest. The provisions of the Miami-Dade County Conflict of Interest and Code of Ethics Ordinance, as may be amended, are applicable to this board.

Section 2. Section 2-533 of the Code of Miami-Dade County, Florida, is hereby amended to read as follows:

Sec. 2-533. Officers; quorum; compensation.

The members of the Board shall elect a chairperson and vice chairperson, who shall serve >> one-year terms << at the will of the Board. >> No member shall remain in the same office for more than two (2) consecutive years. << >> After one (1) year of not holding the office, a member may be elected to the same office that was previously held for up to two (2) consecutive years. <> > Officer elections shall take place each November, with newly elected officers installed the following January. <<

The Office of Community Advocacy's duties shall include working with the Clerk of the Board to ensure the board's membership roster is current and posting minutes from the board's meetings online. In addition, the executive director of the Office of Community Advocacy shall provide a report on the board every twelve months to the Board of County Commissioners.

Section 3. Section 2-534 of the Code of Miami-Dade County, Florida, is hereby amended to read as follows:

Sec. 2-534. Duties, powers and responsibilities.

The Board shall have the following duties, powers and responsibilities:

(d) The Board shall annually report to the Commission as to its >> accomplishments, priorities, << findings and recommendations.

Section 4. Section 2-535 of the Code of Miami-Dade County, Florida, is hereby amended to read as follows:

Sec. 2-535. Supervision and Support.

The Office of the Chairperson of the County Commission, County Attorney and Clerk of the Board shall provide appropriate support for the Hispanic Affairs Advisory Board. The Chairperson of the County Commission shall have the power to appoint, employ, remove and supervise such assistants, employees, and personnel as deemed necessary to provide appropriate support to the Hispanic Affairs Advisory Board, and such assistants, employees, and [[personnel]] >>personnel, including an executive director, collectively herein referred to as the Office of Community Advocacy, << shall serve at the will of the Chairperson of the County Commission.

Section 5. If any section, subsection, sentence, clause or provision of this ordinance is held invalid, the remainder of this ordinance shall not be affected by such invalidity.

Section 6. It is the intention of the Board of County Commissioners, and it is hereby ordained that the provisions of this ordinance, including any sunset provision, shall become and be made a part of the Code of Miami-Dade County, Florida. The sections of this ordinance may be renumbered or relettered to accomplish such intention, and the word "ordinance" may be changed to "section," "article," or other appropriate word.

Section 7. This ordinance shall become effective ten (10) days after the date of enactment unless vetoed by the Mayor, and if vetoed, shall become effective only upon an override by this Board.

BY-LAWS

MIAMI-DADE COUNTY

HISPANIC AFFAIRS ADVISORY BOARD

ARTICLE I NAME

The Miami-Dade County Hispanic Affairs Advisory Board, hereinafter referred to as the Hispanic Affairs Advisory Board (the "Board") was created by the Board of County Commissioners pursuant to Ordinance No. 92-41 on May 19, 1992, which is codified as Section 2-532 in the Code of Miami-Dade County.

ARTICLE II PURPOSE

Section 1. The purpose of the Miami-Dade County Hispanic Affairs Advisory Board shall be to:

- (a) Continuously study the interests and needs of Miami-Dade County citizens who are of Hispanic origin.
- (b) Encourage the interest and involvement of Hispanics in respect to matters pertaining to the Hispanic community in Miami-Dade County.
- (c) Encourage and support the development of Hispanics in leadership roles.
- (d) Formulate and recommend the adoption of legislation supporting matters relevant to and of interest to Miami-Dade County citizens who are of Hispanic origin.

ARTICLE III DUTIES, POWERS AND RESPONSIBILITIES

- Section 1. The Hispanic Affairs Advisory Board shall have the following duties, powers and responsibilities as established in Miami-Dade County Ordinance No. 92-41:
- (a) To serve in an advisory capacity to the county commission, the county administration, the community, and all agencies and persons in Miami-Dade County, Florida, in respect to matters pertaining to the Hispanic community of Miami-Dade County.
- (b) To formulate and recommend plans and programs for coordination of the activities of governmental entities and non-governmental agencies pertaining to the Hispanic community.

- (c) It is the express purpose of this Board to serve as a medium for responsible persons to utilize and consult with in attempting to understand and solve the many complex problems involved with the Hispanic community in Miami-Dade County and to make findings and recommendations to the county commission and the county administration regarding such matters.
- (d) The Board shall annually report to the commission as to its findings and recommendation.
- (e) To perform such other duties as may from time to time be assigned to it by resolution of the county commission.
- Section 2. The Office of Community Advocacy shall supply staff support and shall act as liaison between the Board and the County.

ARTICLE IV MEMBERSHIP

- Section 1. The Miami-Dade County Hispanic Affairs Advisory Board shall be composed of twenty-seven (26) members who shall be permanent residents and electors of the county and who shall have a knowledge of and interest in the county's Hispanic community.
- Section 2. Each county commissioner shall appoint one member of the Board and the other thirteen (13) members shall be nominated by the Board's Nominating Committee and ratified by the Board. All appointments shall be made for a term of four (4) years. No member may serve more than eight (8) consecutive years in accordance with Section 2-11.38.2 of the Code of Miami-Dade County, as may be amended. This section shall apply to all board members, except that current board members shall be allowed to complete their current terms.
- Section 3. No Member shall become a candidate for elective office during his or her term on the Board. A member of the Hispanic Affairs Advisory Board shall resign prior to or will be automatically removed upon becoming a candidate for elective office during his or tenure on the Hispanic Affairs Advisory Board.
- Section 4. Members shall serve without compensation.
- Section 5. The Board's attendance requirement for members shall be in accordance with Section 2-11.39 of the Code of Miami-Dade County, as amended.
 - It shall be the responsibility of each member to attend all Hispanic Affairs Advisory Board meetings and the Sub-Committee meetings of his or her primary assignment.

A board member shall be automatically removed if, in a given fiscal year: (i) he or she is absent from two (2) consecutive meetings without an acceptable excuse; or (ii) he or she is absent from three (3) of the board's meetings without an acceptable excuse. An "acceptable excuse" is defined as an absence for medical reasons, business reasons, or any other reason which the task force, by a two-thirds majority vote of the membership deems appropriate. A member shall also be deemed absent from a meeting when he or she is not present at the meeting at least seventy-five (75) percent of the time.

All requests for excused absences shall be given in writing (faxed, mailed or emailed) to the Executive Director and Chairperson at least 24 hours prior to the meeting.

- Section 6. Upon absences from two (2) consecutive meetings or three (3) unexcused absences, in a given fiscal year, the Executive Director shall notify the Clerk of the Board of County Commissioners, in writing, of the member's removal. The seat shall be deemed vacant effective on the date the Clerk receives the notification. Members' removal from office shall be in accordance with the provisions of Section 2-11.38 of the Code of Miami-Dade County.
- Section 6. Each member shall serve on at least one (1) Sub-Committee.
- Section 7. Any member desiring to resign from the Hispanic Affairs Advisory Board shall submit his or her resignation in writing to the appointing Commissioner (if applicable), the Chairperson and the Executive Director. The Executive Director of the Board shall send a copy of the letter to the Clerk of the Board of County Commissioners The seat shall be deemed vacant on the date the Clerk receives the notification.
- Section 8. The terms of office of members shall begin on the day of appointment and expire when the appointing Commissioner leaves office or the appointing Commissioner's term of office expires. No member shall serve more than eight (8) consecutive years on the Board. Members' terms of office shall be in accordance with the provisions of Section 2-11.38 of the Code of Miami-Dade County.

OFFICERS

Section 1. The members shall elect a Chairperson and a Vice-Chairperson, and a Second Vice-Chairperson. These officers shall perform the duties prescribed by these by-laws and by Mason's Manual of Legislative Procedure, the parliamentary authority adopted by the membership.

- Section 2. At the regular meeting in November, the Chair shall open the floor for nominations starting with the office of Chairperson. Nominees shall be given no more than five minutes to speak prior to a vote. Officers shall be elected by a voice vote if there is only one nominee. If there is more than one nominee, members shall conduct a voice vote and cast a written ballot, to be made a part of the public record, signed by the member casting the vote. Officers' terms of office shall begin at the close of the meeting at which they are elected and they shall serve for two years or until their successors are elected. No vote by proxy shall be permitted. Election shall be by a majority of the votes cast by members present and voting.
- Section 3. No members shall be eligible to serve more than two consecutive terms in the same office.
- Section 4. A vacancy in the office of Chairperson shall be filled by the Vice-Chairperson and a vacancy in the office of Vice-Chairperson shall be filled by the Second Vice-Chairperson. The Vice-Chairperson or Second Vice-Chairperson shall assume the role of Chairperson or Vice-Chairperson, respectively, for the balance of that term or until the Chairperson or Vice-Chairperson returns.
- Section 5. In addition to those duties prescribed by Mason's Manual of Legislative Procedure, the parliamentary authority adopted by the membership, the Chairperson: (i) shall assign members to each Sub-Committee with due consideration given to member's area(s) of interest and the need of the Sub-Committee; (ii) shall present all reports to the Board of County Commissioners; (iii) may appoint a registered parliamentarian at his or her discretion; and (iv) shall serve as the only official representative and spokesperson for the Hispanic Affairs Advisory Board, unless otherwise authorized by a vote of the membership.
- Section 6. The Vice-Chairperson and Second Vice-Chairperson shall be of active assistance to the Chairperson and shall perform the duties of the Chairperson and Vice-Chairperson, respectively, in his or her absence or inability to serve.

ARTICLE VI MEETINGS

Section 1. The regular meetings of the Hispanic Affairs Advisory Board shall be held on the second Tuesday of the month unless otherwise ordered by the membership. Meetings shall be at a time and place designated by the membership; and at least ten regular meetings shall be held during each calendar year. Meetings shall be open to the public at a time and place designated by the Chairperson or Vice-Chairperson. Meetings may also be called by written notice signed by one-half (½) of the members.

- Section 2. The regular meeting in November shall be known as the annual meeting and shall be for the purpose of electing officers, receiving annual reports of Officers and Sub-Committees, and for any other business that may arise.
- Section 3. Special meetings can be called by the Chairperson and shall be called upon the written request of one-half (½) of the members. The purpose of the meeting shall be stated in the call. Except in cases of emergency, at least three days notice shall be given.
- Section 4. At least 50% plus 1 of the full Board membership shall constitute a quorum. The Board is not authorized to take any action without a quorum being present at the meeting.
- Section 5. Each person who desires to address the Board or a committee at a meeting about a proposition or matter before the Board shall notify the Executive Director and request an opportunity to speak about any specific item. The person shall state his or her name and address, if representing an organization and its views the person shall state the organization's name and address. Unless further time is granted by the Board, each individual shall be limited to a statement of three (3) minutes. All remarks shall be addressed to the Board as a whole and not to an individual Board member, No questions shall be asked to individual Board members.
- Section 6. All meetings will be held subject to an in conformance with Miami-Dade County and Florida Conflict of Interest and Open Government Laws, including the "Sunshine Law," public meeting laws, public records laws and the Miami-Dade County Conflict of Interest and Code of Ethics Ordinance.

ARTICLE VII THE EXECUTIVE COMMITTEE

- Section 1. The officers of the Hispanic Affairs Advisory Board shall constitute the Executive Committee.
- Section 2. The Executive Committee shall have general supervision of the affairs of the organization between its business meetings, make recommendations to the membership and shall perform other duties as are specified in these Bylaws. The Chair of the Executive Committee shall be the Chair of the Board. The Executive Committee shall be subject to the orders of the Hispanic Affairs Advisory Board and none of its acts shall conflict with action taken by the organization.
- Section 3. Meetings of the Executive Committee shall be called at a time and place designated by the Chairperson.

ARTICLE VIII

COMMITTEES

- Section 1. The Chair, with the approval of the Board, may designate an Executive Committee, other standing and ad hoc committees from among its members. Each committee, if more than one (1), shall be responsible for performing such duties as are necessary to accomplish the duties, powers, responsibilities and purpose of the Hispanic Affairs Advisory Board, as set forth in these by-laws.
- Section 2. Each committee shall meet at a time, date and place upon the call of its Chair, and such meetings shall be open, announced and publicized.
- Section 3. Reports of committee activities shall be provided in writing at the annual meeting and at such times as they shall be requested by the Chairperson. Copies of reports shall be distributed at least five (5) days prior to the meeting calling for such report.
- Section 4. Unless a greater proportion is required by the Board when designating a Sub-Committee, a majority of the authorized committee membership shall constitute a quorum. The Sub-Committee is not authorized to take any action without a quorum being present at the meeting.

ARTICLE IX PARLIAMENTARY AUTHORITY

Parliamentary procedure shall be conducted in accordance with the most current edition of Mason's Manual of Legislative Procedure, when applicable and not inconsistent with these bylaws, or any special rules of order properly adopted by this Board.

ARTICLE X AMENDMENT OF BY-LAWS

These by-laws may be amended at any regular meeting by a vote of one-half (½) of the <u>active</u> members present and voting, provided that the amendment has been submitted in writing to the membership at least fifteen (15) days prior to the meeting at which it will be considered.

HAAB Major Accomplishments in the Past 24 Months:

- On May 7, 2014 HAAB and the Black Affairs Advisory Board (BAAB) co-hosted "A Civil
 Discourse on Cultural Diversity, Race and Inclusion" in the Commissioner Chambers. The
 event was broadcast live on Miami-Dade T.V. and also streamed on the live Webcast.
- In 2014 and 2015 HAAB collaborated with various commission offices to host the Hispanic Art Expressions exhibits and events in their respective districts.
- In 2015 HAAB collaborated with the Miami Urban Contemporary Experience (a non-forprofit entity) and the Celia Cruz Legacy Foundation to develop and present the Hispanic Heritage Display in the lobby of the Stephen P. Clark Center.
- HAAB coordinated and sponsored a special performance highlighting Hispanic culture at 2015 Asian Culture Festival in collaboration with the Asian Affair's Advisory Board.
- In 2015 HAAB updates and amended the Board's by-laws in collaboration with the County Attorney's Office; the by-laws now reflect current policy measures and procedures.
- Every year between September and October HAAB designs and organizes the Hispanic Art Expressions exhibit at the Stephen P. Clark Center Lobby, along with any organization or entity who requests assistance in putting together a Hispanic Heritage Month display, presentation or performance.
- The Hispanic Art Expressions Exhibit aims to raise awareness of visual arts as a form of the Hispanic culture and help the Miami-Dade County citizens foster a better understanding of each other's roots and cultures. It provides an excellent forum for the constituents and members of the community organizations to interact and expose their issues and concerns.
- In February 2016 HAAB Hosted a Free Tax Event, affording residents the opportunity to have their taxes filed for free by a CPA firm.

HAAB's Major Accomplishments Since Established:

- HAAB was established in 1992; the Board's most significant accomplishments were:
- "Vision 2020" a study and conference covering five years on the vision of What Miami-Dade County Will Be in the Year 2020".
- "Bazaar of Services" held once a year, which is a one-day event where different service providers and organizations get together to inform the citizens about the types of services they offer.
- "Local Government Working for the Community" a program dedicated to educate students on government issues, held three times a year in conjunction with the School System.
- "Entre Hispanos" a series of T.V. programs held at WLRN for one (1) hour every Tuesday for six months, on educational topics of interest to the Hispanic community of Miami-Dade County.
- HAAB in partnership with the Internal Revenue Service hosted "Tax Fairs at the Mall of the Americas and at the Cutler Ridge Mall on Saturdays during tax season, to provide a wide range of free services to the Hispanics citizens of Miami-Dade County. Some of the services that were provided included: Simple income tax preparation; prepare W-7 forms; answer income tax questions and distributed selected IRS Publications and forms. Direct Services were provided to more than 600 people. The tax fair was a yearly project.
- HAAB hosted the "Hispanic Art Expressions" Exhibit throughout the month of October in celebration of Hispanic Heritage. The event was held at various sites within the Hispanic community. The art exhibit featured the talent and richness of local artist from Latin America, the Caribbean and Spain. Over thirteen (13) Latin countries were represented at the exhibit. Its mission is to educate the Miami-Dade County citizens on the richness of the Hispanic Culture. Its main goal is to contribute to the education of economically disadvantage Hispanic students. The participating artist agreed to donate a percentage of the art sales along with sponsor's donations through HAAB to Miami-Dade STARS/HOPE Scholarship Program, an established scholarship program that provides the opportunity of attending MDC to economically disadvantaged students. Direct benefits were provided to Hispanic youth, the exhibit is a yearly project.

- HAAB hosted the "Hispanic Role Model and Future Leader Award Luncheon", which was established by the board to recognize a Role Model, which is an award that is presented to a Hispanic who has contributed to the enhancement and development of business, culture and education in our community.
