Resolution Approving Terms of and Authorizing the Mayor or Mayor's Designee to Execute and File Three Grant Applications with the United States Department of Transportation, Federal Transit Administration for Up to \$89,000,000 in Fiscal Year 2017 Section 5307 Urbanized Area Formula, Section 5337 State of Good Repair Formula, and Section 5339

Bus and Bus Facilities Formula Program Funding

RECOMMENDATION

It is recommended that the Board of County Commissioners (Board) approve the terms of and authorize the Mayor or Mayor's Designee to execute and file three (3) grant applications on behalf of the County with the United States Department of Transportation (USDOT), Federal Transit Administration (FTA) for up to \$89 million in Fiscal Year (FY) 2017 Section 5307 Urbanized Area Formula program, Section 5337 State of Good Repair Formula program, and Section 5339 Bus and Bus Facilities Formula program funding. The total estimated amount includes up to \$55 million in Section 5307, \$28 million in Section 5337, and \$6 million in Section 5339 formula programs funding. It is further recommended that the Board authorize these grant applications pursuant to the agreements, as well as the receipt and expenditure of funds as specified in the agreements.

A public hearing is required in accordance with Federal regulations.

SCOPE

These funds will provide support for multiple bus and rail projects, vanpool and paratransit services and planning activities. Therefore, the impact of these grants is countywide.

FISCAL IMPACT/FUNDING SOURCE

This item represents a positive fiscal impact to the County because it provides funding to the Department of Transportation and Public Works (DTPW) and the required local match up to \$22,250,000 will be provided in full by the Florida Department of Transportation through the use of State Transportation Development Credits as a "soft match" for these grants.

Under the Fixing America's Surface Transportation ACT or (FAST Act), authorization is continued for State Transportation departments to make available to public transit agencies the use of transportation development credits on selected federally assisted public transit capital projects. By using the credits to substitute for the required non-federal share on a new Federal-aid project, the Federal share can effectively be increased to 100 percent.

TRACK RECORD/MONITOR

The County has entered into numerous funding agreements with FTA for nearly 30 years. The Grant Manager for these grants is Ed Carson, DTPW Financial Services.

BACKGROUND

On December 4, 2015, President Obama signed into law the "FAST Act", which provides long-term funding for the 21st Century transportation system. There were no major changes to the current FTA formula grant programs, which include the Section 5307 Urbanized Area Formula, Section 5337 State of Good Repair and Section 5339 Bus and Bus Facilities.

The FTA annually publishes the apportioning funds appropriated by law for these formula grant programs. The Miami Urbanized Metropolitan Area expects to receive approximately \$176,000,000 in Federal FY 2017 formula funds to be divided among the Miami Urbanized Metropolitan Area (Miami-Dade, Broward, Palm Beach Counties and the South Florida Regional Transportation Authority, SFRTA). The amount of funding each agency receives is based upon the apportioned funds, information from the National Transit Database (NTD) and the appropriate formula established by the FTA. The agency directors within the Miami Urbanized Metropolitan Area mutually agree on the split amount for the 5307, 5337, and 5339 formula grant programs and the SFRTA distributes written notification of the final apportionment to each agency.

The Section 5307 Formula program makes Federal funding available to urbanized areas for public transportation capital, planning, job access and reverse commute projects and use of certain expenditures by vanpool operators and operating assistance in areas with populations greater than 200,000 operating a maximum of 100 buses in fixed-route service during peak hours (rail fixed guideway excluded). For urbanized areas with populations of 200,000 and more, the formula is based on a combination of bus revenue vehicle miles, bus passenger miles, fixed guideway revenue miles, and fixed guideway route miles, as well as population, population density, and number of low-income individuals. The proposed projects expected to be funded up to \$55 million under the FY 2017 Section 5307 program for DTPW includes:

- Preventive Maintenance (PM) Bus
- Capital Planning
 - o General development/Comprehensive Planning
 - Short-range transportation planning
- Paratransit (Special Transportation Services) using capital cost of contracting
- South Florida Vanpool Program Services using capital cost of contracting
- Metrorail/Metromover Train Control Equipment
- Camera project (use of one (1) percent program allocation required by FTA for security)
- Metrorail/Metromover Cable Replacement Equipment

Projects funded under the Section 5337 State of Good Repair Formula program are limited to replacement and rehabilitation of existing fixed guideway systems or capital projects required to maintain public transportation systems in a state of good repair. Funds are apportioned to urbanized areas with fixed guideway systems in operation for at least seven (7) years and a new modified formula. The proposed DTPW projects expected to be funded up to \$28 million under the FY 2017 Section 5337 program includes:

Preventive Maintenance (PM) Rail

The Section 5339 Bus and Bus Facilities Formula program provides funding to replace, rehabilitate and purchase buses and related equipment and construct bus-related facilities and use of certain expenditures by vanpool operators. The formula is based upon population, vehicle revenue miles and passenger miles. The proposed DTPW projects expected to be funded up to \$6 million under the FY 2017 Section 5339 program includes:

- South Florida Vanpool Services using capital cost of contracting
- 40-foot Buses

The FTA annually publishes the apportioning funds appropriated by law for these formula grant programs. The Miami Urbanized Metropolitan Area anticipates receiving up to \$176 million in Federal FY 2017 formula funds to be divided among the Miami Urbanized Metropolitan Area (Miami-Dade, Broward, and Palm Beach Counties, and the South Florida Regional Transportation Authority). The amount of funding each agency receives is based upon the apportioned funds, information from the NTD and the appropriate formula established by the FTA. The agency Directors within the Urbanized Metropolitan Area mutually agree on the final apportionment to each agency.

The combined formula grants funding (\$89 million) reflects an estimated amount that the County will receive from the FY 2017 appropriation. Upon approval by the Board, DTPW as an eligible designated recipient of federal funding will submit separate grant applications to the FTA for each formula program.

Application Executive Summary

This grant application is for \$1,684,625 Federal Fiscal Year (FFY) 2015 Section 5339 Bus and Bus Facilities Formula funds. The total allocation to Miami-Dade Transit (MDT) for the Section 5339 Bus and Bus Facilities Formula program funds appropriated by Congress for FFY 2015 is \$8,395,541. MDT was awarded \$3,355,458 in a grant (FL-34-0028) on August, 12, 2015. This grant funding represented MDT's allocation based upon the 8/12th (\$6,747,480) in contract authority allocated by Congress to the Miami-Urbanized Area and was the budget authority available for the period October 1, 2014 through May 31, 2015.

The current appropriation (\$1,684,625) represents the remaining 4/12 of the total appropriation prorated based on the amount of budget authority available for the period of July 1, 2015 through September 30, 2015. A copy of the split letter dated October 23, 2015; signed by MDT, Broward County Transit (BCT), South Florida Regional Transportation (SFRTA) and Palm Tran showing the agreed upon sub-allocation is attached to the Project Information section of this application. Also attached is a copy of the April 7, 1975 letter approving MDT as a designated recipient for the Miami Urbanized Area.

MDT will use the \$1,684,625 federal funding from this grant application to complete the following projects:

- 1) Metrobus Seat Inserts MDT currently uses a fabric seat insert on its buses. MDT will use \$575,861 \$1,684,625 to complete the retrofitting of seats on 225 buses with fiberglass inserts at a cost of approximately \$2,559 per bus for a total project cost of \$575,861. The estimated useful life for the seat inserts is 10 years.
- 2) Electric Engine Cooling Systems MDT will use \$1,050,000 of the \$1,684,625 to purchase new forty-two (42) Electrical Engine Cooling Systems, which will replace the Conventional Hydraulic Cooling Systems. This will eliminate engine overheating experienced by mass transit buses due to harsh start-stop conditions. The total estimated project cost is \$1,050,000. The estimated useful life for the engines is 10 years.
- 3) MDT South Florida Vanpool Service MDT intends to take over the vanpool program effective July 1, 2016. This program has been operated by the Miami-Dade MPO since 1998. The SFVP covers Miami-Dade, Broward and Palm Beach Counties. MDT will use \$58,764 of the \$1,684,625 for the MDT South Florida Vanpool Program (SFVP).

MDT was provided \$117,046 funding for this project from the initial FFY 2015 Section 5339 Bus & Bus Facilities Formula funds appropriated by Congress for the period October 1, 2014 through May 31, 2015. The total cost of the services provided under the vanpool contract is estimated at approximately \$5,191,473. Of this amount, \$2,076,589 is an eligible capital cost for contracting expenses with an



allowable ratio of 40%. The total allocation for this project from the full FFY 2015 Section 5339 Bus & Bus Facilities appropriation is \$175,810. The balance needed of \$1,900,779 will be from the FFY 2015 FTA Section 5307 Urbanized Area formula grant. MDT plans to utilize passenger fares in excess of operating expenses as the local match. The final scope of services has been attached under the project details section. The final vanpool contract will be attached when available.

The Section 5339 Urbanized Area Formula funding is identified as item # FM-436881-1, in the current Florida Department of Transportation (FDOT) Five-Year Work Program (2016-2020), and on page 5283 of the FY 2016 State Transportation Improvement Program (STIP). This Item was added to the FY 2016, Miami-Dade Metropolitan Planning Organization (MPO) Transportation Improvement Program (TIP) on September 29, 2015, by amendment (MPO Resolution #30-15). Copies of the STIP page and the FTA/FHWA STIP approval letter dated 09/30/2015; and MPO Resolution # 30-15 is attached to the project information section of this grant application.

The required local match for this grant application will be provided by FDOT using \$421,156 in Transportation Developments (TDC) as a "soft match" for \$1,684,625 in Fiscal Year (FY) 2015 Federal Transit Administration (FTA) Section 5339 Bus and Bus Facilities Formula Program.

A copy of the October 23, 2015 TDC letter is attached to the Project Information Section of this application. The Resolution authorizing the filing of this grant application is (R-438-15), which was adopted by the Board of County Commissioners on May 5, 2015. A copy of the approved resolution is attached to the Project Information section.

MDT will follow all third-party procurement policies as defined in C 4220.1F (Third Party Contracting Guidance) and will ensure contractors procured will not be on the FTA Suspension and Debarment list.
