RESOLUTION WAIVING BY A TWO-THIRDS VOTE OF ITS MEMBERSHIP, THE RESIDENCY REQUIREMENTS OF SECTION 2-11.38 AND SECTION 17-133 OF THE CODE OF MIAMI-DADE COUNTY AND APPOINTING SHEKERIA BROWN TO THE AFFORDABLE HOUSING TRUST FUND BOARD OF TRUSTEES

WHEREAS, section 17-133 of the Code of Miami-Dade County requires that one member of the Affordable Housing Trust Fund Board of Trustees be designated by the South Florida Community Development Coalition; and

WHEREAS, the South Florida Community Development Coalition has designated its executive director, Shekeria Brown, as its designee to the Affordable Housing Trust Fund Board of Trustees; and

WHEREAS, section 2-11.38 of the Miami-Dade County Code requires that all members of County boards be permanent residents of Miami-Dade County; and

WHEREAS, section 17-133 of the Miami-Dade County Code requires that all members of the Affordable Housing Trust Fund Board of Trustees be permanent residents and duly qualified electors of Miami-Dade County; and

WHEREAS, Shekeria Brown is a resident of Broward County; and

WHEREAS, Shekeria Brown maintains significant connection to the entire Miami-Dade County community; and

WHEREAS, Shekeria Brown's dedication and service to the South Florida Community

Development Coalition has significantly contributed to this County; and

**WHEREAS**, pursuant to section 2-11.38 of the Miami-Dade County Code, the Board is authorized by a two-thirds vote of its membership to waive this residency requirement; and

WHEREAS, pursuant to section 17-133 of the Miami-Dade County Code the Board of County Commissioners is authorized by a two-thirds vote of its membership to waive this residency requirement; and

WHEREAS, this Board wishes to waive these residency requirements and allow the appointment of Shekeria Brown to the Affordable Housing Trust Fund Board of Trustees; and

WHEREAS, a copy of Shekeria Brown's resume is attached,

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board, by a two-thirds vote of its membership, waives the residency requirements set forth in section 2-11.38 and section 17-133 of the Code, and appoints Shekeria Brown to the Affordable Housing Trust Fund Board of Trustees.
