RESOLUTION AMENDING RESOLUTION NOS. R-647-08, R-32-07, R-131-06 AND R-160-05 TO EXEMPT FOUR UNITS OF THE TOTAL 160 UNITS FROM THE AFFORDABILITY REQUIREMENTS **MIAMI-DADE** INTHE REGULATORY AGREEMENT IN ORDER TO PERMIT LAFAYETTE SQUARE, LTD. TO HOUSE ONE MANAGER AND THREE SECURITY OFFICERS, AND APPROVING SECOND AMENDMENT TO SUCH AGREEMENT **EFFECTUATE SAME AND** TO CORRECT THE **AFFORDABILITY BREAK-DOWN** AMONGST THE REMAINING 156 UNITS, ALL IN CONNECTION WITH A \$7,697,643.00 DOCUMENTARY STAMP SURTAX LOAN FOR LAFAYETTE SQUARE APARTMENTS; AND DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO **EXECUTE AMENDMENT** TO THE RENTAL REGULATORY AGREEMENT; AND WAIVING RESOLUTION NO. R-130-06

WHEREAS, this Board pursuant to Resolution Nos. R-647-08, R-32-07, R-131-06 and R-160-05, respectively, allocated to Lafayette Square, Ltd. ("Lafayette Square"), Documentary Stamp Surtax in the total amount of \$7,697,643.00 (the "Loan") for the construction of a 160 unit affordable housing project known as Lafayette Square Apartments (the "Project") located at 150 N.E. 79<sup>th</sup> Street, Miami, Florida; and

WHEREAS, as a condition of the Loan, Lafayette Square was required to execute a Miami-Dade County Rental Regulatory Agreement ("Rental Regulatory Agreement"), as amended by the First Amendment to Rental Regulatory Agreement, copies of which are attached hereto as Exhibits "A" and "B" and incorporated herein by reference; and

WHEREAS, the Rental Regulatory Agreement includes the affordability requirement that 84 of the units be set aside for individuals and/or families that have incomes equal to or less than 60 percent of area median income, and 76 of the units be set aside for individuals and/or families that have incomes equal to or less than 50 percent of area median income; and

WHEREAS, the Rental Regulatory Agreement further provides that of the total units 24 of the units will be set aside for Section 8 Housing Choice Voucher holders and 25 of the units for large families; and

WHEREAS, on January 4, 2016, Lafayette Square sent a letter to Miami-Dade Public Housing and Community Development Department, a copy of which is attached hereto as Exhibit "C" and incorporated herein by reference, to request that the County exempt four of the 160 units to be set aside for one management unit and three security officer units; and

WHEREAS, according to Lafayette Square the reason for this request is due to the high rate of crime in the area; and

WHEREAS, Lafayette Square has submitted as an attachment to their letter crime rate data for the area; and

WHEREAS, on June 18, 2012, Lafayette Square submitted a similar request to the Florida Housing Finance Corporation for the exemption of the four units; and

WHEREAS, the Florida Housing Finance Corporation pursuant to a letter dated June 21, 2012, a copy of which is attached hereto as Exhibit "D" and incorporated herein by reference, granted Lafayette Square's request to exempt the four units; and

WHEREAS, in light of the supporting evidence of the high crime rate in and around the Project, this Board desires to amend the Rental Regulatory Agreement to exempt four units in the Project in order to permit Lafayette Square to house one manager and three security officers; and

WHEREAS, this Board wishes to waive Resolution No. R-130-06, which provides that an item seeking approval of a contract shall not be placed on a County Commission or committee agenda until the underlying contract is completely negotiated, in final form, and executed by all non-County parties, to provide additional time to the County Mayor or County Mayor's designee to finalize the terms of the amendment to the Rental Regulatory Agreement,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. The foregoing recitals are incorporated in this Resolution and are approved.

Section 2. This Board hereby amends Resolution Nos. R-647-08, R-32-07, R-131-06 and R-160-05 to exempt four of the 160 units from the affordability requirement in the Rental Regulatory Agreement whereby all units be set aside for individuals and/or families that have incomes equal to or less than 60 percent and 50 percent of area median income so that they can be used to house one manager and three security officers for the Project.

Section 3. This Board approves the second amendment to the Rental Regulatory Agreement in substantially the forms attached hereto as Exhibit "E" and incorporated herein by reference, and directs the County Mayor or County Mayor's designee to execute same. The County Mayor or County Mayor's designee is further authorized to correct the affordability breakdown amongst the remaining 156 units in the Project.

Section 4. This Board waives Resolution No. R-130-06 to provide additional time to the County Mayor or the County Mayor's designee to finalize the terms of the amendment to the Rental Regulatory Agreement.

WHEREAS, MIAMI-DADE COUNTY, a political subdivision of the State of Florida (the "County") is authorized to loan TWO MILLION FIVE HUNDRED THOUSAND AND 00/100 DOLLARS (\$2,500,000,00) (the "Loan") to LAFAYETTE SQUARE, LTD., a Florida limited partnership, its heirs successors and assigns (hereinafter referred to as the "Owner") for the purposes outlined and pursuant to the conditions set forth in the Mortgage and Security Agreement (the "Mortgage"), the Collateral Assignment of Leases, Rents and Contract Rights (the "Assignment"), the Loan Agreement, and the Promissory Note in favor of the County executed simultaneously with this Rental Regulatory Agreement (the "Agreement") (hereinafter referred to as "Loan Documents"); and

WHEREAS, in connection with receipt of the Loan, the Owner agrees to maintain the rents at certain prescribed rates as set forth in this Agreement; and

NOW, THEREFORE, for and in consideration of ten dollars (\$10.00), the promises and covenants contained in this Agreement and other good and valuable consideration received and acknowledged as of the Zi day of November, 2006, the Owner, whose address is c/o The Gatehouse Group, 120 Forbes Boulevard, Mansfield, Massachusetts 02048; Attention, Mr. Marc'S. Planskier, its successors, heirs and assigns, and the County, whose address is 111 N.W. 1street, Miami, Florida 33128; Attention: County Manger, hereby agree as follows:

#### WITNESSETH:

- I. Owner agrees with respect to the Property for the period beginning on the date of recordation of the Mortgage securing the Loan, and ending on the last day of the thirty (30) year period after the date of the recordation; that:
  - (a) Bighty Pour (84) of the Units in the Complex shall be set aside for rental to persons or households with incomes equal to or below sixty percent (60%) of the local median income minus tenant paid utilities (determined at the time of initial occupancy), which shall be adjusted for family size. Seventy Six (76) of the Units in the Complex shall be set aside for rental to persons or households with incomes equal to or below fifty percent (50%) of the local median income minus tenant paid utilities (determined at the time of initial occupancy), which shall be adjusted for family size. Twenty Four (24) of the above Units shall be set aside and may be rented to holders of a housing voucher. Twenty Five (25) of the above Units will be set aside for large families (three bedroom units) which may be rented to five or more persons. Accordingly, the maximum initial tental rates for this Property are indicated in Exhibit "B" attached bereto.
  - (b) The above rentals will include the following services for each unit; refrigerator, water heater, oven, vinyl or tile in bathrooms and kitchens, carpeting or tile and air conditioning. Owner will be responsible for trash removal.
  - (c) Miami Dade Housing Agency (the "Agency"), or its successor agency, may give written notice of any violation of this Agreement to the Owner, by registered mail, at the address stated in this Agreement, or such other address or addresses as may subsequently be designated by the Owner in writing to the Agency, and in the event Owner does not cure such default (or take measures reasonably satisfactory to the Agency to cure such default), within 30 (thirty) days after the date of notice, or within such further time as the Agency may allow, without further notice, declare a default under the Mortgage and/or this Agreement, and effective upon the date of such default, the Agency may:
    - Declare the whole indebtedness under the Promissory Note evidencing the Loan immediately due and payable and then proceed with foreclosure of the Mortgage;
    - (2) Apply to any Court, County, State or Federal, for any specific performance of this Agreement; for an injunction against the violation of this Agreement; or for such relief as may be appropriate since the injury to the Agency arising from a default remaining uncured under any of the terms of this Agreement would be irreparable, and the amount of damage would be difficult to ascertain.

II. The Agency and Owner agree that rents may increase as median income increases as published by U.S. HUD or in order to bring rents up to the limits set forth in section 1(a) herein. Any other adjustments to rents will be made only if the Agency finds any adjustment is necessary to support the continued financial viability of the project and only by an amount that the Agency determines is necessary to maintain continued financial viability of the project.

Owner will provide documentation to justify a rental increase request not attributable to increases in median income. Within thirty (30) days of receipt of such documentation, the Agency will approve or deny, as the case may be, all or a portion of the rental increase in excess of the amount that is directly proportional to the most recent increase in median annual income. In the event any portion is denied, the Agency will state specifically the reasons therefor. In no event, however, will any increase directly proportional to an increase in median annual income be denied for any reason.

- III. Except as otherwise noted, all parties expressly acknowledge that the Agency shall perform all actions required to be taken by Miami-Dade County pursuant to Paragraphs IV, V, VI and VII hereof for the purpose of monitoring and implementing all the actions required under this Agreement. In addition, the Owner shall furnish the Agency with copies of the notification provided to tenants advising them of the increase upon request.
- IV. Occupancy Reports.

The Owner shall, on an annual basis, furnish the Agency with an occupancy report, which provides the following information:

- A list of all occupied apartments, indicating composition of each resident family, as
  of the end date of the reporting period.
- B) A list of all vacant apartments, as of the end date of the reporting period.

The Owner shall upon request of the Agency allow representatives of the Agency to review and copy any and all of its executed leases with tenants residing on the Property.

- C) The total number of vacancies that occurred during the reporting period.
- The total number of units that were re-rented during the reporting period, stating family size and income.
- V. Inspections.

Pursuant to 42 U.S.C. § 12755, the Owner shall maintain the Property in compliance with all applicable federal housing quality standards, receipt of which is acknowledged by the

Owner, and contained in Sec. 17-1, et seq., Code of Miami-Dade County pertaining to minimum housing standards (collectively, "Housing Standards").

- A) The Agency shall annually inspect the Property, including all dwelling units and common areas, to determine if the Property is being maintained in compliance with the Housing Standards. The Owner will be furnished a copy of the results of the inspection within 30 (thirty) days, and will be given 30 (thirty) days to correct any deficiencies or violations of the Housing Standards.
- B) At other times, at the request of the Owner or of any tenant, the Agency may, in its discretion, inspect any unit for violations to the Housing Standards.
  - The teriant and the Owner will be provided with the results of the inspection and the time and method of compliance and corrective action that must be taken.
- C) The dwelling units shall contain at least one bedroom of appropriate size as determined by the Agency in its reasonable discretion, for each two persons.
- VI. The Agency Review and Approval of Lease Agreement, Selection Policy and Management Plan.

Prior to initial rent-up and occupancy, the Owner will submit the following documents to the Agency:

- A) Proposed form of resident application.
- B) Proposed form of occupancy agreement.
- C) Applicant screening and tenant selection policies, if any.
- D) Maintenance and management plan which shall include the following information:
  - A schedule for the performance of routine maintenance such as up-keep of common areas, extermination services, etc.
  - A schedule for the performance of non-routine maintenance such as painting and reconditioning of dwelling units, painting of building exteriors, etc.
  - 3. A list of equipment to be provided in each dwelling unit,
  - A proposed schedule for replacement of dwelling equipment.
  - A list of tenant services, if any, to be provided to residents.

The Owner agrees that the Agency has the right to refer eligible applicants for housing.

#### VII. Financial Reports.

Annually, the Owner shall transmit to the Agency a certified annual operating statement showing project income, expenses, assets, liabilities, contracts, mortgage payments and deposits to any required reserve accounts.

The Agency will review the operating statement to insure conformance with all the provisions confained in this Agreement.

B) The Owner will create a reserve for maintenance to be funded at \$200.00 per unit per year. This reserve may be combined with reserve accounts required by any other parties making loans to Owner and will be deemed satisfied by any deposits made by Owner in accordance with such loan documents that equal or exceed \$200.00 per unit per year.

#### VIII, Action By or Notice to the County:

Unless specifically provided otherwise herein, any action to be taken by, approvals made by, or notices to or received by the County required by this Agreement shall be taken, made by, given or delivered to:

#### IX. Non-Recourse:

Notwithstanding anything provided herein to the contrary, neither the Owner, nor any of its shareholders, officers, directors or employees shall have any personal liability under the terms of this Agreement. In the event of a default by the Owner under this Agreement, which default is not cured within any applicable cure period, the County's sole remedy hereunder shall be limited to exercising its rights under this Agreement to proceed against the real and personal property encumbered by the Mortgage, but shall not include a right to proceed directly against the owner, or any of its shareholders, officers, directors or employees, or seek, obtain, enforce or collect a money judgment against Owner or any of its shareholders, officers, directors of employees or their assets, except for the Property.

### FIRST AMENDMENT TO RENTAL REGULATORY AGREEMENT

THIS FIRST AMENDMENT ("Amendment") is made and entered into as of November \_\_\_\_, 2009 by and between Miami-Dade County, a political subdivision of the State of Florida (the "County") and Lafayette Square, Ltd., a Florida limited partnership (the "Owner"),

WHEREAS, pursuant to authorizing Resolutions Nos. R-160-05 and R-131-06, adopted February 1, 2005 and January 24, 2006, respectively, the County allocated to the Owner Documentary Stamp SURTAX funds in the amount of Two Million Five Hundred Thousand Dollars (\$2,500,000) (the "Initial SURTAX Funds");

WHEREAS, in connection with the allocation of Initial SURTAX Funds, the County and the Owner entered into that certain Rental Regulatory Agreement recorded on December 19, 2006 in Official Records of Miami-Dade County at Book 25205, Pages 0332-0340 (the "Agreement"); and

WHEREAS, pursuant to authorizing Resolutions Nos. R-32-07 and R-647-08, adopted January 25, 2007 and June 3, 2008, respectively, the County allocated to the Owner additional SURTAX funds in the amount of Five Million One Hundred Ninety Seven Thousand Six Hundred Forty-Three and 00/100 Dollars (\$5,197,643) (the "Additional SURTAX Funds"); and

WHEREAS, the County shall allocate State Housing Initiative Partnership Program (SHIP) 2007 funds in the amount of Five Million One Hundred Ninety Seven Thousand Six Hundred Forty-Three and 00/100 Dollars (\$5,197,643) (the "SHIP Funds") in exchange for and in lieu of the Additional SURTAX Funds; and

WHEREAS, the undersigned desire to amend the Agreement to reflect the allocation of the Additional SURTAX Funds and the subsequent allocation of the SHIP Funds in exchange for and in lieu of the Additional SURTAX funds;

NOW, THEREFORE, in consideration of Ten Dollars (\$10.00), the mutual promises of the parties hereto, and of other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto, intending legally to be bound, hereby agree as follows:

1. All rent and other restrictions and agreements binding upon the Owner pursuant to the Agreement are hereby ratified and confirmed and shall continue in full force and effect with respect to the Initial SURTAX Funds and with respect to the SHIP Funds.

### FIRST AMENDMENT TO RENTAL REGULATORY AGREEMENT

WHEREAS, pursuant to authorizing Resolutions Nos: R-160-05 and R-131-06, adopted February 1, 2005 and January 24, 2006, respectively, the County allocated to the Owner Documentary Stamp SURTAX funds in the amount of Two Million Five Hundred Thousand Dollars (\$2,500,000) (the "Initial SURTAX Funds");

WHEREAS, in connection with the allocation of Initial SURTAX Funds, the County and the Owner entered into that certain Rental Regulatory Agreement recorded on December 19, 2006 in Official Records of Miami-Dade County at Book 25205, Pages 0332-0340 (the "Agreement"); and

Eighty Four (84) of the Units in the Complex shall be set aside for rental to persons or households with incomes equal to or below sixty percent (60%) of the local median income minus tenant paid utilities (determined at the time of initial occupancy), which shall be adjusted for family size. Seventy Six (76) of the Units in the Complex shall be set aside for rental to persons or households with incomes equal to or below fifty percent (50%) of the local median income minus tenant paid utilities (determined at the time of initial occupancy), which shall be adjusted for family size. Twenty Four (24) of the above Units shall be set aside and may be rented to holders of a housing voucher. Twenty Five (25) of the above Units will be set aside for large families (three bedroom units) which may be rented to five or more persons. Accordingly, the maximum initial rental rates for this Property are indicated in Exhibit "B" attached hereto.

The above rentals will include the following services for each unit; refrigerator, water heater, oven, vinyl or tile in bathrooms and kitchens, carpeting or tile and air conditioning. Owner will be responsible for trash removal.

- (c) Miami Dade Housing Agency (the "Agency"), or its successor agency, may give written notice of any violation of this Agreement to the Owner, by registered mail, at the address stated in this Agreement, or such other address or addresses as may subsequently be designated by the Owner in writing to the Agency, and in the event Owner does not cure such default (or take measures reasonably satisfactory to the Agency to cure such default), within 30 (thirty) days after the date of notice, or within such further time as the Agency may allow, without further notice, declare a default under the Mortgage and/or this Agreement, and effective upon the date of such default, the Agency may:
  - (1) Declare the whole indebtedness under the Promissory Note evidencing the Loan immediately due and payable and then proceed with foreclosure of the Mortgage;
  - (2) Apply to any Court, County, State or Federal, for any specific performance of this Agreement; for an injunction against the violation of this Agreement; or for such relief as may be appropriate since the injury to the Agency arising from a default remaining uncured under any of the terms of this Agreement would be irreparable, and the amount of damage would be difficult to ascertain.

II. The Agency and Owner agree that rents may increase as median income increases as published by U.S. HUD or in order to bring rents up to the limits set forth in section 1(a) herein. Any other adjustments to rents will be made only if the Agency finds any adjustment is necessary to support the continued financial viability of the project and only by an amount that the Agency determines is necessary to maintain continued financial viability of the project.

Owner will provide documentation to justify a rental increase request not attributable to increases in median income. Within thirty (30) days of receipt of such documentation, the Agency will approve or deny, as the case may be, all or a portion of the rental increase in excess of the amount that is directly proportional to the most recent increase in median annual income. In the event any portion is denied, the Agency will state specifically the reasons therefor. In no event, however, will any increase directly proportional to an increase in median annual income be denied for any reason.

III. Except as otherwise noted, all parties expressly acknowledge that the Agency shall perform all actions required to be taken by Miami-Dade County pursuant to Paragraphs IV, V, VI and VII hereof for the purpose of monitoring and implementing all the actions required under this Agreement. In addition, the Owner shall furnish the Agency with copies of the notification provided to tenants advising them of the increase upon request.

### IV. Occupancy Reports.

The Owner shall, on an annual basis, furnish the Agency with an occupancy report, which provides the following information:

- A) A list of all occupied apartments, indicating composition of each resident family, as of the end date of the reporting period.
- B) A list of all vacant apartments, as of the end date of the reporting period.

The Owner shall upon request of the Agency allow representatives of the Agency to review and copy any and all of its executed leases with tenants residing on the Property.

- C) The total number of vacancies that occurred during the reporting period.
- D) The total number of units that were re-rented during the reporting period, stating family size and income.

### V. Inspections.

Pursuant to 42 U.S.C. § 12755, the Owner shall maintain the Property in compliance with all applicable federal housing quality standards, receipt of which is acknowledged by the

Owner, and contained in Sec. 17-1, et seq., Code of Miami-Dade County pertaining to minimum housing standards (collectively, "Housing Standards").

- A) The Agency shall annually inspect the Property, including all dwelling units and common areas, to determine if the Property is being maintained in compliance with the Housing Standards. The Owner will be furnished a copy of the results of the inspection within 30 (thirty) days, and will be given 30 (thirty) days to correct any deficiencies or violations of the Housing Standards.
- B) At other times, at the request of the Owner or of any tenant, the Agency may, in its discretion, inspect any unit for violations to the Housing Standards.
  - The tenant and the Owner will be provided with the results of the inspection and the time and method of compliance and corrective action that must be taken.
- C) The dwelling units shall contain at least one bedroom of appropriate size as determined by the Agency in its reasonable discretion, for each two persons.
- VI. The Agency Review and Approval of Lease Agreement, Selection Policy and Management Plan.

Prior to initial rent-up and occupancy, the Owner will submit the following documents to the Agency:

- A) Proposed form of resident application.
- B) Proposed form of occupancy agreement.
- C) Applicant screening and tenant selection policies, if any.
- D) Maintenance and management plan which shall include the following information:
  - 1. A schedule for the performance of routine maintenance such as up-keep of common areas, extermination services, etc.
  - 2. A schedule for the performance of non-routine maintenance such as painting and reconditioning of dwelling units, painting of building exteriors, etc.
  - 3. A list of equipment to be provided in each dwelling unit.
  - 4. A proposed schedule for replacement of dwelling equipment.
  - 5. A list of tenant services, if any, to be provided to residents.

The Owner agrees that the Agency has the right to refer eligible applicants for housing.

#### VII. Financial Reports.

A) Annually, the Owner shall transmit to the Agency a certified annual operating statement showing project income, expenses, assets, liabilities, contracts, mortgage payments and deposits to any required reserve accounts.

The Agency will review the operating statement to insure conformance with all the provisions contained in this Agreement.

B) The Owner will create a reserve for maintenance to be funded at \$200.00 per unit per year. This reserve may be combined with reserve accounts required by any other parties making loans to Owner and will be deemed satisfied by any deposits made by Owner in accordance with such loan documents that equal or exceed \$200.00 per unit per year.

### VIII. Action By or Notice to the County:

Unless specifically provided otherwise herein, any action to be taken by, approvals made by, or notices to or received by the County required by this Agreement shall be taken, made by, given or delivered to:

#### IX. Non-Recourse:

Notwithstanding anything provided herein to the contrary, neither the Owner, nor any of its shareholders, officers, directors or employees shall have any personal liability under the terms of this Agreement. In the event of a default by the Owner under this Agreement, which default is not cured within any applicable cure period, the County's sole remedy hereunder shall be limited to exercising its rights under this Agreement to proceed against the real and personal property encumbered by the Mortgage, but shall not include a right to proceed directly against the owner, or any of its shareholders, officers, directors or employees, or seek, obtain, enforce or collect a money judgment against Owner or any of its shareholders, officers, directors of employees or their assets, except for the Property.



### SECOND AMENDMENT TO RENTAL REGULATORY AGREEMENT

THIS SECOND AMENDMENT ("Amendment") is made and entered into as of \_\_\_\_\_\_, 20\_\_\_\_ by and between Miami-Dade County, a political subdivision of the State of Florida (the "County") and Lafayette Square, Ltd., a Florida limited partnership (the "Owner").

WHEREAS, pursuant to authorizing Resolutions Nos. R-647-08, R-32-07, R-131-06 and R-160-05 adopted on June 3, 2008, January 25, 2007, January 24, 2006 and February 1, 2005, respectively, the County allocated to the Owner Documentary Stamp Surtax Funds in the total amount of Seven Million Six Hundred Ninety-Seven Six Hundred Forty-Three Dollars and No/100 (\$7,697,643.00) (the *Surtax Funds*");

WHEREAS, in connection with the allocation of the SURTAX Funds, the County and the Owner entered into that certain Rental Regulatory Agreement recorded on December 19, 2006 in Official Records of Miami-Dade County at Book 25205, Pages 0332-340 of the Public Records of Miami-Dade County (the "Agreement"); and

WHEREAS, the County and the Owner subsequently entered into that First Amendment to Rental Regulatory Agreement recorded on October 28, 2007 in Official Records of Miami-Dade County at Book 27471, Pages 2657-2660 of the Public Records of Miami-Dade County to account for additional Surtax funds allocated to the project

WHEREAS, at the Owner's request the County has agreed that four (4) of the units at the Property (as such term is defined in the Agreement) that are set aside for rental to persons or households with income equal to or below sixty percent (60%) and fifty percent (50%) of the local median income (the "Units") shall be exempt units as further set forth herein; and

WHEREAS, the undersigned desire to amend the Agreement to provide for four (4) exempt units as further set forth herein,

NOW, THEREFORE, in consideration of Ten Dollars (\$10.00), the mutual promises of the parties hereto, and of other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto, intending legally to be bound, hereby agree as follows;

- 1. Owner may use one (1) of the Units for a management unit and three (3) of the Units for security officers units. As long as the Units are used as set forth in the previous sentence of this Section 1, then such units shall be exempt from the Agreement's requirements and restrictions.
- 2. Except as set forth herein, all rent and other restrictions and agreements binding upon the Owner pursuant to the Agreement, as amended, are hereby ratified and confirmed and shall continue in full force and effect with respect to the Surtax Funds.

	3. Paragraph I (a) of the Rental Regulatory Agreement is further amended to read as
follow	s:
	persons or households with incomes equal to or less than sixty percent (60%) of the area median income ("AMI") adjusted for family size, minus tenant-paid utilities; and () Units in the Complex shall be set aside for rental to persons or households with incomes equal to or less than fifty percent (50%) of AMI adjusted for family size, minus tenant-paid utilities () of the above Units will be set aside for large families (three-bedroom units) which may be rented to five or more persons. Accordingly, the maximum initial approved rental rates for this Property are indicated in Exhibit "B" attached

4. Exhibit B of the Rental Regulatory Agreement is hereby deleted and replaced with Exhibit B, attached hereto and incorporated herein by reference.

- 5. This Amendment contains the entire understanding of the parties with respect to the subject matter hereof and supersedes any prior understandings and agreements between them with respect thereto.
- 6. Other than the foregoing, all other terms and conditions of the Agreement shall remain in full force and effect and are ratified and confirmed in all respects by the parties hereto.
