Resolution Approving the Waiver of Plat of Arturo Del Rio

Recommendation

The following waiver of plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This waiver of plat for Arturo Del Rio is bounded on the north approximately 450 feet south of SW 98 Street, on the east approximately 370 feet west of SW 83 Avenue, on the south by SW 100 Street, and on the west approximately 130 feet east of SW 84 Avenue.

The Miami-Dade County Plat Committee recommends approval of this waiver of plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources (Department).

Scope

This waiver of plat is located in Commission District 7, which is represented by Commissioner Xavier L, Suarez.

There is no fiscal impact to Miami-Dade County with the approval of this waiver of plat as all improvements are in place.
