Resolution Authorizing Submittal of Grant Application to Florida Inland Navigation

District Waterways Assistance Program for up to \$1,507,256.00 with Matching County Funds of \$1,614,334.00 Funded in Part with Building Better Communities General Obligation Bond Funds and Coastal Park and Marina Trust Funds to Design, Permit, and

Construct a Portion of Haulover Promenade at Haulover Park

Recommendation

It is recommended that the Board of County Commissioners (Board) authorize the County Mayor or County Mayor's designee to apply to Florida Inland Navigation District's Waterways Assistance Program (FIND) for \$1,507,256.00 with matching County funds of \$1,614,334.00 to design, permit, and construct a portion of Haulover Promenade. It is further recommended that the Board authorize the County Mayor or County Mayor's designee to receive and expend funds; and execute grant agreements, certain amendments, and other documents as required by the grant agreement upon review and final approval of the County Attorney's Office.

Scope

Haulover Park is located at 11800 Collins Avenue, Miami Beach, in County Commission District 4, which is represented by Commissioner Sally A. Heyman.

Fiscal Impact/Funding Source

The County's estimate of the project cost is \$3,018,940.00. If awarded, the FIND grant will provide funds of \$1,507,256.00 and the County will provide \$1,200,000.00 from the Coastal Park and Marina Trust Fund, Index Code PRE600945082, and \$414,334.00 from the Building Better Communities Bond Fund, Project No. 20, Index Code CPK020PR0739. The FIND estimated total project cost of \$2,809,212.00 is less than the County's estimated project cost of \$3,018,940.00 because FIND disallows in-house costs such as project management and bidding, and award costs from the grant program. The maximum FIND grant is 50 percent of FIND's allowed project costs. The County match provides funding sufficient to complete the project. After completion, the annual maintenance cost of this segment of the Promenade is estimated to be \$50,000.00 which will be included in the Parks, Recreation and Open Space's (PROS) annual operating budget, Index Code PREHAU438731.

Track Record/Monitor

FIND is a Special Taxing District for the continued management and maintenance of the Atlantic Intracoastal Waterway. FIND has awarded \$4,759,300.00 in grants since 2012 to the PROS. The proposed grant will be administered by PROS Grants Manager, Nicole Anderson.

Background

The application is due to be mailed by March 30, 2017 and is required to be accompanied by the adopted resolution. If awarded, the grant term will begin October 2017 and end September 2019. The project is scheduled to be completed within the grant term, but, if needed, a one-year extension is allowed upon request.

As part of the application process it is required that a resolution be adopted in substantially the form of this resolution by the applicant for FIND grant funds. Amendments will only be made in conformance with this resolution where no additional matching funds or other County funds are encumbered, otherwise Board approval will be required to make amendments to the grant.

SUBMITTAL OF GRANT RESOLUTION AUTHORIZING Α APPLICATION TO THE FLORIDA INLAND NAVIGATION DISTRICT WATERWAYS ASSISTANCE PROGRAM, FOR \$1,507,256.00 WITH MATCHING COUNTY FUNDS OF \$1,614,334.00 TO DESIGN, PERMIT AND CONSTRUCT A PORTION OF THE HAULOVER PROMENADE AT HAULOVER PARK; AND FURTHER AUTHORIZING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO RECEIVE AND EXPEND FUNDS, AND EXECUTE GRANT AWARD AGREEMENTS, CERTAIN AMENDMENTS AND OTHER DOCUMENTS AS REQUIRED BY FLORIDA INLAND NAVIGATION DISTRICT AND THE GRANT UPON REVIEW AND FINAL APPROVAL OF THE COUNTY ATTORNEY'S OFFICE FOR LEGAL SUFFICIENCY

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

WHEREAS, Miami-Dade County is interested in carrying out the following described project for the enjoyment of the citizenry of Miami-Dade County and the State of Florida:

Project Title: Design, Permit and Construct of Sections 1, 2 and 3 of Haulover Promenade

Total Florida Inland Navigation District (FIND) Estimated Cost: \$2,809,212.00

Brief Description of Project: Designing, Permitting and Constructing Sections 1, 2 and 3 of Haulover Promenade; and

WHEREAS, FIND financial assistance is required for the project mentioned above; and WHEREAS, as part of its application process, FIND requires that a resolution be adopted by the agency seeking FIND grant funds in substantially the form of this resolution,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board authorizes the submittal of a grant application for \$1,507,256.00 to FIND Waterways Assistance Program with County matching funds of \$1,614,334.00 of which \$414,334.00 shall be funded from the Building Better Communities Bond Program, and \$1,200,000.00 from the Coastal Park and Marina Trust Fund,

AND, BE IT FURTHER RESOLVED that said Miami-Dade County shall make application to the FIND in the amount of up to 50 percent of the FIND estimated cost on behalf of Miami-Dade County,

AND, BE IT FURTHER RESOLVED by Miami-Dade County that it certifies to the following:

- 1. That it will accept the terms and conditions set forth in FIND Rule 66B-2 F. A. C. and which will be a part of the project agreement for any assistance awarded under the proposal.
- 2. That it is in complete accord with the proposal for Haulover Promenade and that it will carry out the project in the manner described in the proposal and any plans and specifications attached thereto unless prior approval for any change has been received from FIND.
- 3. That it has the ability and intention to finance its share of the cost of the project and that the project will be operated and maintained at the expense of said Miami-Dade County for public use.

- 4. That it will not discriminate against any person on the basis of race, color or national origin in the use of any property or facility acquired or developed pursuant to this proposal, and shall comply with the terms and intent of the Title VI of the Civil Rights Act of 1964, P. L. 88-352 (1964) and design and construct all facilities to comply fully with statutes relating to accessibility by handicapped persons as well as other federal, state and local laws, rules and requirements.
- 5. That it will maintain adequate financial records on the proposed project to substantiate claims for reimbursement.
- 6. That it will make available to FIND, if requested, a post-audit of expenses incurred on the project prior to, or in conjunction with, request for the final 10% of the funding agreed to by FIND.

AND, BE IT FURTHER RESOLVED that the Board authorizes the County Mayor or County Mayor's designee to execute grant award agreements, amendments and other documents FIND and the grant require, following approval by the County Attorney's Office as to legal sufficiency; provided, however, that the County Mayor or Mayor's designee are only delegated the authority to execute amendments that do not have an additional fiscal impact on the County and that otherwise are for projects eligible under the FIND, Waterways Assistance Program. The Board authorizes the County Mayor or Mayor's designee to receive and expend all monies for the purposes described in the funding request for an on behalf of Miami-Dade County, Florida.
