RESOLUTION APPROVING THE CITY OF SOUTH MIAMI CODESIGNATION OF S.W. 64TH STREET FROM S.W. 62ND AVENUE TO S.W. 59TH PLACE AS "PASTOR RODNEY B. JAMES STREET"

WHEREAS, on December 20, 2016, the City of South Miami adopted Resolution No. 246-16-14801, which codesignated that portion of Southwest 64th Street from Southwest 62nd Avenue to Southwest 59th Place as "Pastor Rodney B. James Street" in memory of Pastor Rodney B. James's work as a community leader; and

**WHEREAS**, a copy of Resolution No. 246-16-14801 is attached hereto and incorporated herein by reference; and

WHEREAS, Pastor James was pastor of the Mount Olive Missionary Baptist Church of South Miami and President of the City of South Miami's Concerned Clergy and Citizens Coalition; and

WHEREAS, Pastor James was a relentless advocate for the City of South Miami, working together with City and County officials for the construction of the Murray Park Pool and serving as a liaison between community members and the South Miami Police Department; and

WHEREAS, Pastor James passed away on December 14, 2016, survived by his wife Carla and three children; and

**WHEREAS**, Pastor James will be remembered for his thunderous voice and community advocacy; and

WHEREAS, Southwest 64th Street from Southwest 62nd Avenue to Southwest 59th Place is a city road located in the City of South Miami; and

WHEREAS, this codesignation is located in County Commission District 7; and

WHEREAS, the City of South Miami would like for the County to install signage indicating this codesignation on County street signs and traffic signal mast arms; and

WHEREAS, this Board would also like to honor Pastor Rodney B. James by approving the City of South Miami codesignation of Southwest 64th Street from Southwest 62nd Avenue to Southwest 59th Place as "Pastor Rodney B. James Street",

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the City of South Miami codesignation of Southwest 64th Street from Southwest 62nd Avenue to Southwest 59th Place as "Pastor Rodney B. James Street".

Section 2. Directs the Clerk of the Board to transmit a certified copy of this resolution to the Mayor and City Commission of the City of South Miami, the United States Postal Service, the Traffic Signals and Signs Division of the Department of Transportation and Public Works, the Development Services Division of the Regulatory and Economic Resources Department, the Miami-Dade Police and Fire Rescue Departments, and the City of South Miami Police Department.

## **RESOLUTION NO. 246-16-14801**

A Resolution of the Mayor and City Commission of the City of South Miami, Florida, Codesignating a portion of S.W. 64th Street between S.W. 62nd Avenue and S.W. 59th Place as "Pastor Rodney B. James Street" directing the City Clerk to submit this Resolution to Miami-Dade County and to take all other necessary actions to carry out the purpose of this Resolution.

WHEREAS, Pastor James celebrated his Pastoral Anniversary this past October; and

WHEREAS, Pastor James was appointed the Chaplain for the South Miami Police Department; and

WHEREAS, Pastor James was the President of the South Miami Concerned Clergy and Citizens Coalition; and

WHEREAS, Pastor James had served as Vice President of Florida East Coast Baptist Association-Progressive Kingdom Baptist Association; and

WHEREAS, Pastor James is survived by his wife Carla and children, Royce, and twins Remington and Zamaria; and

WHEREAS, the City Commission wishes to co-designate a portion of S.W. 64th Street as "Pastor Rodney B. James Street".

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF SOUTH MIAMI, FLORIDA, THAT:

Section 1. The City Commission wishes to co-designate a portion of S.W. 64<sup>th</sup> Street between S.W. 62<sup>nd</sup> Avenue and S.W. 59th Place as "Pastor Rodney B. James Street", and that it shall, as soon as authorized by Miami Dade County, be known in and by the City of South Miami as "Pastor Rodney B. James Street", and S.W. 64th Street, and signs shall be made and installed declaring that designation. The City Clerk is directed to submit this Resolution to Miami-Dade County and to take all other necessary actions to carry out the purpose of this Resolution.

Section 2. This Resolution shall be provided to the US Postal Service and to the appropriate agencies to codesignate a portion of S.W. 64th Street between S.W. 62nd Avenue and S.W. 59th Place as "Pastor Rodney B. James Street", and S.W. 64th Street.

Section 3. This Resolution shall take effect immediately upon its adoption.
